ORDINANCE NO. 151956

An Ordinance repealing Ordinance No. 122384, which granted a revocable permit to Lois L. Jacobson to place aluminum facia in the street area, and Ordinance No. 150451, which amended the insurance requirements, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- Lois L. Jacobson, 6308 S.E. Foster Road, Portland, 97206, requested to place and maintain, on an existing building, an aluminum facia which extended into the street area of S.E. Foster Road less than 22 inches.
- 2. That the insurance requirements were updated to reflect current insurance requirements by Ordinance No. 150451.
- 3. That the permittee has since been issued a street obstruction permit in accordance with Section 17.44.010 of the City Code.
- 4. That the permit granted by Ordinance No. 122384 is no longer needed.

NOW, THEREFORE, the Council directs:

a. Ordinance No. 122384 entitled "An Ordinance granting a revocable permit to Lois L. Jacobson, 6308 S.E. Foster Road, Portland, Gregon, to place and maintain, on an existing building, an aluminum facia which will extend not more than 22 inches into the street area of S.E. Foster Road between S.E. 63rd Avenue and S.E. 64th Avenue, and declaring an emergency." and Ordinance No. 150451 entitled "An Ordinance amending Ordinance No. 122384, which granted a revocable permit to Lois L. Jacobson to place an aluminum facia in the street area, by updating the insurance requirement contained in Section 1(b), adding additional conditions, and declaring an emergency." are hereby repealed.

ORDINANCE No.

Section 2. The Council declares that an emergency exists in that there be no delay in clearing the records of unnecessary ordinances; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
