Emergency Ordinance

***Authorize a competitive solicitation and contract with the lowest responsible bidder for the Central Eastside Access and Circulation Project**

Passed

The City of Portland ordains:

Section 1. The Council finds:

1. The Central Eastside Access and Circulation project will improve freight access and circulation and reduce multimodal conflicts in the Central Eastside by adding and modifying traffic signals.
2. The project is consistent with the adopted SE Quadrant, Central City 2035 and Central City in Motion plans.
3. The Bureau of Transportation has funds budgeted in FY 2022 and proposed FY 2022 for construction, inspection and management of the project.
4. The Bureau's level of confidence in the cost estimate for this project is moderate; the project is defined and plans and specifications are nearing completion.

NOW, THEREFORE, the Council directs:

- A. The Chief Procurement Officer is authorized to facilitate the competitive solicitation process in accordance with City Code 5.34 to obtain the lowest most responsible bidder.
- B. Upon the Council's acceptance of the Chief Procurement Officer's report recommending the lowest responsible bidder, the Chief Procurement Officer is authorized to award, negotiate and execute a contract, provided the contract has been approved as to form by the City Attorney's Office.

Budget Office Financial Impact Analysis

This legislation will authorize PBOT to bid the Central Eastside Access and Circulation project. The total project budget is \$5.6 million. Costs for this project to be posted in PBOT's Capital Project T00718.C42 which has been included in the bureau's FY 2021-22 Adopted Budget and five-year CIP forecast. The project funding sources include Transportation System Development Charges (\$2.4M) and local (non-federal) Metro grant (\$3.2M).
