RECITALS:

WHEREAS, Community Cycling Center and the City are Parties to “City Contract #32002375 Subrecipient Agreement, Project: Portland Bureau of Transportation- Parkrose School District Safe Routes to School” signed May 6, 2021 (The “Agreement”); Authorized on March 24, 2021, by Ordinance No. 190332; and

WHEREAS, On October 26, 2021, Metro, the grant administrator formally notified project managers that the three-year grant will be extended for an additional fourth year due to the pandemic. The additional year allows for continued work on existing transportation demand management projects and/or changes to programming in response to the pandemic; and

WHEREAS, the Parties wish to amend the Agreement to set forth a new expiration date for completion of the parties’ obligations and responsibilities in connection with providing Parkrose School District Safe Routes to School programming.

NOW, THEREFORE, the Parties hereby agree as follows:

- I. The Agreement is amended to:
 - a. Update the expiration date of 6/30/2022 to 6/30/2023 in “Section B: Effective Date and Duration”
 - b. Update the total Agreement amount and not to exceed to \$25,000 in “Section D: Compensation”
 - c. Update performance report schedule in Exhibit A to include an additional four quarters as outlined below.
