NORTHWEST DISTRICT DEVELOPMENT ASSOCIATION Minutes of Executive Committee Meeting Thurdday, January 7, 1971

The meeting of the Board convened at 1956 N. W. Irving Street. Ogden Beeman, vice-president of the Association, presided and called the meeting to order. Mr. Beeman then read a letter directed to the Board from Mr. George Drougas in which he resigned from the office of President of the Association due to the fact that he now resided outside of the Northwest Portland area. Discussion followed as to who would act as president for the remainder of this term of office. The Constitution does not specifically provide for this situation. In the absence of this it was agreed by the members of the Board that Mr. Beeman would act as President for the remainder of the term.

Edd Crawford reported on a meeting held with School District #1 relative to Couch School. The question arose as to whether or not this Association should become involved in this type of situation. A motion was made, seconded and carried that a letter be directed to members of the School Board indicating our interest in expressing the Association's position ; and, telling them that we would come forthme with the Association's stand on the subject before January 28th. It was further agreed that Dennis West and Fr. Scheefers follow through.

Dennis West then introduced Mr. Gene Zeitelin and Mr. Jack Sanders who presented a film showing made some years ago involving urban renewal projects. In this connection they, as students of urban studies at Portland State University, presented their plan to prepare an urban study of Northwest Portland. And to do this certain financial backing would be necessitated. The following motion was then made, seconded and carried: "That the Association co-sponsor the proposed film with the Urban Studies Center; that the making of the film be under the jurisdiction of the Urban Studies Center; and, that it be consistent with the Planning Committee study of the over-all Northwest Portland area."

The next General Membership meeting of the Association was then discussed. The time was set for Tuesday, January 19, 1971; and, since Mr. Beeman would not be in the City at that time, it was agreed that Llano Thelin chair that meeting. The agenda for that meeting would for the most part involve the Middle School situation and the future plans for the use of Couch School as an educational facility. Since too little information from the School Board was available at this time, the Association's Board agreed that the School Board should give us more detailed information on its plans for Both Couch and Chapman Schools. Therefore, it was agreed that some members of the School Board appear at the January 19th meeting to give some information regarding its plans so that the Association would be able to act if desired.

Minutes of General Membership Meeting

Tuesday, January 19, 1971

This meeting of the Association convened at 7:30, P.M., at Trinity Eppscopal Church, N. V. 19th & Everett St., with Llano G. Thelin acting as Chairman in the absence of Ogden Beeman.

Chairman Thelin called the meeting to order and began the evening's program by introducing Mr. Jonothan Newman of the School Board. Mr. Newman proceeded to explain the operation of the school board and explained that the District is divided into three areas; and, that Northwest Fortland is located in what is known as Area I. Attached to each area is a Citizens' Advisory Committee. Various meetings were being planned in various areas by the Advisory Committee where interested persons might meet to discuss proposed changes in the School District's program involving the Middle Schools, K-5 Schools and Metropolitan Learning Centers. Following Mr. Newman's presentation a period of discussion between members of the Association and Mr. Newman took place. In this matter, also, Mr. Newman assured the group that the School Board had up to this time made no plans for re-structuring of the school facilities in Northwest Portland.

Mrs. Ogden Beeman announced to the meeting upcoming dates for P.T.A. Meeting at Chapman School. She also spoke of the possibility of a Spring Festival program which would come about through the combined efforts of the Chapman School P.T.A, the Capt. Brown House Ass'n. and Northwest District Development Association, etc.

Continuing with the program for this meeting Chaiman Thelin called upon Mr. Edgar Waehrer, the Association's Planning Committee Chairman. Mr. Waehrer reported on the Committee's program and particularly with reference to census-taking throughout the Northwest Portland as to people living in the Thurman-Vaughn Street corridor. He called for Volunteers to assist in this study.

It was announced that on Thursday, January 21, at 2:00, p.m., at meeting would be held to consider alternatives in connection with School Planning Program.

On January 26th a meeting of the Zoning Committe would take place to consider zone - change requests (1) at Flanders St. & 17th Ave. and (2) on Northrup between 24th & 25th.

There being no further business to come before the maeting, the same was declared adjourned.

The meeting of the Board of the Association convened at 4:30, P.M., at 1956 N. W. Everett Street. Mr. Ogden Beeman presided and called the meeting to order.

The first item for consideration was the hearing scheduled for March 10th at the Portland City Council wherein the City Council would consider recommendations of the Portland Planning Commission to the State Highway Commission on the I-505 Freeway being planned along the Thurman-Vaughn Street corridor in Northwest Portland.

It was agreed that this matter be brought to the attention of the Association at the February 16th meeting and then vote on the direction the Association wants to take with respect to the hearing to be held on March 10th.

The second subject of discussion for the forthcoming Association meeting was the decision to be reached concerning the Middle School situation in Northwest Portland. It was suggested that a joint neighborhodd meeting be held to consider the Middle School plan instead of having the regular Association General Membership Meeting. This suggestion was not agreeable to the majority of the Board and it was then decided to hold the regularly scheduled Association meeting on February 16 at which time alternatives for the Middle School program would be presented to the meeting and a decision reached by the membership as to the Association's stand rethe Middle School in Northwest Portland.

The agenda then for the February 16th Association meeting was the I-505 Freeway decision along the Thurman-Vaughn Street Corridor and decision concerning the Middle School proposals. This meeting is planned for the Morrison RoOm of Trinity Episcopal Church.

MINUTES OF GENERAL MEMBERSHIP MEETING

Tuesday, February 16, 1971

The meeting of the general membership of the Association convened at the Morrison Room of Trinity Episcopal Church, N. W. 19th & Everett Streets. President Ogden Beeman presided and began by giving a brief resume of the work of the Association that had been accomplished and projects currently being carried on.

Mr. Beeman then presented Mr. Ed Waehrer, Chairman of the Association's Planning Committee, who discussed the matter of the use of Couch School and Chapman School as facilities for middle schools or K-5 schools. In this connection Mr. Waehrer indicated the following possibilities :

- I) Converting Chapman School to Middle School Use only.
- II) Converting Couch School to Middle School use only.
- III) Building a new facility

Following Mr. Waehrer's presentation Mr. Beeman called for comments and suggestions from the floor, after which he asked the people to indicate their preference as to Items I, II and III by a show of hands. A show of hands as to Items I and II indicated that those present did not favor converting either Couch School or Chapman School to Middle School facilities. As to Item III a show of hands indicated those present in favor of the building of new facilities for Middle School use.

The following motion was then made and seconded: Retain Couch School as an educational facility and continue the Metropolitan Learning Center department.

The following amendment was then offered to the original motion: "To include in the original motion that the K-5 school at Couch School be retained there as long as possible." This amendment was seconded.

A vote was then taken on the amendment to the original motion and the same was carried. A vote was then taken on the original motion with the amendment added and the same was carried.

A motion was then made to request the School Board to investigate the possibility of using Couch School as an educational and community center facility. This motion was seconded and carried.

Mr. Beeman then introduced Mr. John Parry of the Portland Planning Commission who discussed the matter of the I-505 Freeway and the possible uses of the land use along the Thurman-Vaughn Street corridor. Following Mr. Parry's discussion Mr. Beeman called for comments from the floor. At the conclusion of the open discussion the Association voted to adopt the following positions:

- 1.) To support the concept of multiple use of the corridor.
- 2.) That the same number of residential units taken out by the Freeway be replaced within Northwest Portland.
- 3.) That families who are relocated by the Freeway be permitted to remain in Northwest Portland; that replacement housing be supplied.
- 4.) That Freeway traffic, both coming on and off, be reouted to the north side of the Freeway; that the Association does not consider any North-South streets as arterials, but rather as neighborhood commercial streets.
- 5.) To adopt the objectives of the Planning Committee as the objectives of the Association.

There being no further business to come before this meeting the same was declared adjourned.

STAFF REPORT

<u>SUBJECT</u>: Selection of Middle School Site - Lincoln High Area NWDDA MEETING: February 16, 1971

Discussion: On March 23, 1970 the Board of Education for the Portland Public Schools (School District Number One) formally adopted a far reaching policy for the reorganization of the Portland School System. Among the policy conclusions adopted by the Board was the following: "The present kindergarten through eighth grade elementary school organization shall be changed to establish primary schools consisting of all grades through the fourth grade, and middle schools for grades 5 through 8." The grades proposed for the middle schools have since changed to 6 through 8.

The implementation of this program will have far reaching implications on the environment of our neighborhoods. In most cases, the present lower schools serve as anchors for residential neighborhoods. Attempts in the past have been made by school planners to locate the lower schools within the center of the neighborhoods they serve with attendance districts drawn to eliminate dangerous street crossings. All of this was done to promote a neighborhood where children had a swift and safe walk to school and to after school facilities such as playgrounds.

Lower schools in Portland have become the focal point and image of many of our neighborhoods. They seem particularly valuable as a means of holding and attracting families to closein neighborhoods.

The middle schools will, whenever possible, be converted from existing primary (K-8) schools and they are to have an attendance of 900 to 1200. Because of the large attendance area, the majority of students will have to be bused. Location, therefore, is not nearly as critical as with lower schools.

At the present time there appears to be four alternatives:

- 1. Convert Chapman to a middle school. Couch would then become the lower school for the Northwest District.
- 2. Convert Couch to a middle school with Chapman serving as the lower school for the Northwest District.

- 3. Convert or build a new facility outside the Northwest District. Chapman would become the lower school in this instance and Couch would either become a specialized school (M.L.C.?) or surplus property.
- 4. Maintain the status quo.

In selecting a middle school site the following questions should be asked:

- 1. In the case of remodeling an existing primary school, would the resultant loss of the primary school be damaging to the neighborhood? In this sense, perhaps we should think first in terms of protecting the best located lower schools and then consider, among those schools leftover, which would best be suited to conversion to a middle school.
- 2. Would conversion to a middle school have a damaging effect on the neighborhood? This could happen in a number of ways; acquisition of additional site could mean loss of needed community facilities (housing, shopping, etc.), conversion of parks from general use to an organized sport use could also be damaging. Some neighborhoods will simply not be capable of gracefully assimilating 900-1200 early teenage children.

MINUTES OF MEETING OF GENERAL MEMBERSHIP OF NORTHWEST DISTRICT DEVELOPMENT ASSOCIATION Tuesday, March 16, 1971

The meeting of the Association convened at the Morrison Room of Trinity Episcopal Church, N. W. 19th & Everett streets. Mr. Ogden Beeman, president of the Association, called the meeting to order at 7:30, P.M.

Mr. Beeman then introduced as the first speaker of the evening Mr. Robert Sheffield of the Multhomah County Assessor's office. Mr. Sheffield spoke to the meeting on the regulations and methods of the Assessor's office used to determine evaluations on real property for the purpose of tax assessments. He indicated that it is the assessor's job to estimate the current true cash value of the properties and develop a tax rate based on these values. True cash value means the market value of the property. It has been the goal of the assessor's office that property be appraised at least once each six years; and, that re-appraisal cycle is moving to a five-year schedule. He further explained that the longer the re-appraisal cycle the greater the re-evaluation of the property assessment under the present inflationary trends. Mr. Sheffield further explained the method of appeals open to property owners who are not in aggreement with the appraised value set by the assessor's office. These are as follows:

- 1. File appeal with County Assessor's office on "blue form" application.
- 2. Second appeal then to the State Board of Equalization.
- 3. Third appeal to the Department of Revenue.
- 4. Fourth appeal to the Oregon Tax Court.

Mr. Sheffield estimated that approximately 40% - 50% of appeals received favorable results to the property owner.

The next topic for the evening was a report on the outcome of the public hearing before the Portland City Council relative to its acceptance of the City Planning Commission recommendations for multiple land use along the Thurman-Vaughn Street corridor that will be adjacent to Interstate I-505. Mr. Beeman first gave an historical background of the work of the Association, in conjunction with the City Planning Commission, in formulating its recommendations. He then introduced Rev. Llano G. Thelin who reported on the activities at the Council that took place on Wednesday, March 10th. He remarked that the City Council appeared to be greatly impressed with the orderly and well-presented position of the Association. He stated further that he, Mr. Ed Waehrer, and Mr. Lou Himes made presentations on behalf of the Association; and, that numerous other speakers came forward to speak for themselves personally or on behalf of small businesses and other organizations in the Northwest Portland area. Rev. Thelin stated that there appeared to be a tremendous solidification from all forms of citizenry in the Northwest Area. He then reported that following the various presentations Commissioner Frank Ivancie moved that the "Blue Book" report prepared by the City Planning Commission on its study of the area and extracts from the presentations made at the public hearing be forwarded to the State Highway Department for its use in planning the I-505 Freeway along the Thurman-Vaughn Street corridor. This motion was seconded by Commissioner Connie McCready.

Mr. Beeman then introduced Mrs. Janice Bruckner who has been spearheading the relocation of the Capt. Brown house. Mrs. Bruckner briefly explained some of the progress being made on this project and then introduced Mr. Geo. Sheldon. He then displayed a sketch indicating a plan for re-landscaping Couch Park that would be considered an improvement for the students at Couch School as well as the people living in the area. He stated that the school approved of this plan and that efforts were being made to obtain matching funds from the Federal Government to accomplish this work.

The next item for consideration at this meeting was the adoption of a recommendation to change the name of the Association from Northwest District Development Association to Northwest District Association. Mrs. Susan Storms, who made the original motion then spoke in favor of the name change. She then made a motion that the name of the Association be hereafter known as "NORTHWEST DISTRICT ASSOCIATION". This motion was seconded and carried.

Llano Thelin then recommended that plans be made to induce the Executive Board of Good Samaritan Hospital to meet with the Executive Board of Northwest District Association for an exchange of ideas relative to objectives of the hospital. In this connection he then moved that the Association authorized its Executive Committee to meet with the Board of Directors of Good Samaritan Hospital to share objectives and to learn what the hospital's plans are with respect to its expansion if Northwest Portland. This motion was seconded.

Following this motion Mr. Art Busse moved that the motion be amended as follows: "To request of the Board of Directors of Good Samaratan Hospital that any plans they might have for the enlargment of its facilities be made public and that details of the proceedings of the meeting between the hospital board and the Association"s board be **minum** shared with the members of the Association." Mr. Busse's amendment to Rev. Thelin's motion was seconded and carried. Following this the motion originally made by Rev. Thelin was carried.

Mr. Harold Sims then inquired of those present at the meeting if anything definite was known as to the future plans for use of the old St. Vincent's Hospital building. No definite information was then available; and, Mr. Beeman then asked Mr. Sims to make inquiries and report back to the Association the results of his findings.

John Parry of the City Planning Commission then spoke of the Commissions current plan to make a house-to-house survey of the Northwest Portland area. He reported that Mr. Dave Yaegen was in charge of this project and that considerable help was needed from persons within the Association or area to assist in this survey. Mr. Yaegen then spoke on this subject stating that the results of the Commission's survey of the Thurman-Vaughn Street corridor area indicated a strong similarity to a like survey made by the Planning Committee of Northwest District Association; and, therefore, demonstrated the importance of a continuance of the survey to obtain a true picture of Northwest Portland.

There being no further business to come before the meeting the same was declared adjourned.

NORTHWEST DISTRICT ASSOCIATION MINUTES OF EXECUTIVE COMMITTEE MEETING

April 8, 1971 - 4:30, P.M.

A meeting of the Executive Committee of the Association convened at 1956 N. W. Everett St. In attendance were Howard Glazer, John Ross, Ogden Beeman, Sue Storms and Astrid Berg. Ambrose Seliger, Executive Secretary, was also in attendance.

The first topic for discussion was the matter of having a general membership meeting on April 20th. Mr. Beeman stated that he would have to be out of town on that date, but that if a meeting were held he would ask Llano Thelin to conduct the meeting. It appeared that the group favored scheduling the April 20th meeting in order to retain the interest that the community seemed to express. An agenda for the meeting was then discussed. The following items were agreed upon for the April 20th meeting: (1) Obtain report concerning city building inspections being conducted in N. W. Portland; and, if possible, get a speaker from the City Engineer's office to make a presentation. (2) Bring up before the meeting three zone change requests for consideration of the membership; (a) Application for zone change at N. W. 17th & Everett St. (Chown Hdwe), (b) application for zone change at 24th Ave. between Northrup & Marshall St. for Marshall St. Clinic; and, (c) application for use of land for parking lot for Good Samaritan Hospital on Marshall Street between 21st and 22nd Ave.

The matter of appointing a nominating committee for the selection of candidates for next year's officers and directors was considered. Mr. Beeman suggested that a mne-man committee be appointed, and that that person select others to work with him. It was suggested that Llano G. Thelin be appointed as chairman of the nominating committee.

Mr. Beeman stated that Mr. John Parry of the Portland Planning Commission has recommended to the City Council that the neighborhood planning concept is valid and that City Council recognize the input of the Association.

As to the I-505 Freeway planning, it appears that the Cur-point program of this Association may become the recommendation of City Council.

Mr. Beeman announced that it had been learned that the remaining budgeted amount allocated for use by the Portland Planning Commission for its study of N.W. Portland has been included in this year's budget of the City of Portland.

Mr. Beeman reported on efforts being made by Llano Thelin and himself to arrange for a joint meeting of the Board of Directors of Good Samaritan Hospital and Northwest District Association. In this connection he offered for consideration of the Executive Committee an agenda that would be submitted to the hospital board for its consideration as an agenda for the joint board meeting.

There being no further business to come before this meeting the same was declared adjourned.

MOTION MADE BEFORE NORTHWEST DISTRICT ASSOCIATION AT REDULAR MEETING, APRIL 20,1971

That we direct a request to Tri-Met to provide public transportation from Northwest Portland to North and Northeast Portland via the direct route of the Broadway Bridge. It is not the intent of this motion that these busses should in any way go through downtown before reaching their Northwest, North or Northeast destinations.

The intent is that public transportation be provided directly over the Broadway Bridge to N.E. Broadway and 42nd Ave. area - Memorial Coliseum, Sears, Food Stamp office, Lloyd Center and hospitals and other Eastside connections to travel up either N.W. Marshall or N.W. Lovejoy to 25th Avenue, thus making it possible for the public to move directly in either direction without the time and distance required to go through the core area of town and transfer to another bus.

This would eliminate many transfers as well as a distance of 29 blocks of travel.

In support of this there are many people employed in the Northwest section in industry, hospitals, etc. who live in the North and Northeast section; and conversely, many residents of the Northwest section would like to utilize the facilities of the North and Northeast section with a minimum amount of time expended.

It is conceivable that this crosstown service would facilitate and increase the numbers of persons who would avail themselves of Tri-Met Service to the N.W. Hospital and facilities core area and also to North and N.E. Hospital core areas and shopping centers.

This motion was made by Joe Gallagher and seconded by Edd Crawford, President of Friendly House.

MINUTES OF GENERAL MEMBERSHIP MEETING

Tuesday, April 20, 1971 - 7:30, P.M.

The general membership meeting of the Association convened in the Great Hall of Trinity Episcopal Church. In the absence of Mr. Beeman, Llano G. Thelin acted as chairman of the meeting and called the same to order.

Chairman Thelin began the meeting by introducing members of a Planning & Study group for the Tri-met Transit System. A color film showing was given with a speaker from the Tri-Met study group narrating. Bus routes were discussed, as well as fare structures. Several pictures indicated types of sheltered bus-stops being planned throughout the area and types of busses that are planned for the future. Following this presentation an open discussion took place. At this time also Mr. Joe Gallagher made a suggestion that Tri-Met consider a bus route across the Broadway Bridge direct to Northwest Portland and return to East Portland via the Broadway Bridge. This route, according to Mr. Gallagher, would encourage added bus travelers because it would serve the many hospital, nursing home, clinic and docotors' offices employees and would not require these people to bus to the downtown area to transfer to other parts of Portland. A detailed summary of this plan is attached to an been included as part of these minutes.

The following motion was then made, seconded and carried: "That Northwest District Association go on record as recommending that Tri-Met Transit System and the Tri-Met Study Group consider a lateral bus route coming off Broadway Bridge and across Northwest Portland and return to Broadway Bridge, rather than requiring riders to go downtown to transfer to the **as**t side of Portland.

The second portion of this meeting turned to certain city zone-change requests affecting property in Northwest Portland. Howard Glazer, chairman of the association's zoing committee, first discussed an application by Chown Hardware for a zone change from A-o to M-3 to allow for a parking area. Mr. John Parry, of the Portland Planning Commission, displayed color;film slides of the area in question and gave additional details concerning the zone change request. Following this, the Association ratified Mr. Glazer's recommendation that this zone-change request be denied; and, to also recommend that the lot be used for Parking by Chown Hardware on a conditional use permit only.

The next zoning situation for disucssion was a request by Marshall Street Clinic to construct a parking lot for five automobiles on the land adjacent to the Clinic on Marshall Street. It appeared that the Clinic had purchased a house and lot here and desired to put a parking lot on the part of the lot on which the house was located. XMA John Parry then showed color slides of this area and the clinic and house in; question. Following this the Association voted to recommend that the parking lot not be permitted in this area. Mr. R. J. McGarrity, member of this Association, asked to go on record as voting in opposition to the Association's recommendation.

The third zoning change request was in regards to two houses owned by Good Samaritan Hospital on Northrup Street. The Hospital desires to raze these two houses and were asking for zoning permit to convert the two lots to parking lots. In this connection the Association voted as follows: "That the Association go on record asking that a more torium be obtained against the removal of these two houses until the Association hears further from the Hospital as to itskfuture plans for expansion; and, also, that any plans for paving these two lots be delayed.."

The next item of business for this evening's meeting was a presentation to be made concerning inspections currently being made of houses in Northwest Portland by the Portland Engineering Department. Mr. Johnson of that department discussed this matter and explained that these inspections were currently being made on the west side of 23rd Avenue from Burnside Street to Thurman and Vaughn Streets. He furtherexplained that deficiencies found by inspectors required correction by the property owner. He further indicated that inspections were not being made in the area east of 23rd Avenue due to the fact that most housing in that area was considered too poor to warrant rehabilitation.

The meeting then adjourned.

On Monday, May 24, 1971, the members of the 1970-71 and 1971-72 Executive Committees of the Northwest District Association and members of the Board of Trustees of Good Samaritan Hospital and Medical Center met at a joint meeting in the Conference Room of Good Samaritan Hospital. The meeting convened at 4:00 p.m.

Mr. Ogden Beeman, past president of the Northwest District Association, opened the meeting by introducing members of the Association's Executive Committee who were in attendance. Mr. Fred Wessinger, president of the Board of Trustees of Good Samaritan Hospital and Medical Center, then introduced members from the Hospital's Board. Following introductions, Mr. Wessinger gave a general description of the goals of the hospital - improvement of the range, quality and accessibility of health services, modernization or replacement of substandard or nonconforming hospital facilities compatible with neighborhood architectural and landscaping aesthetics. In this connection, he distributed among the persons present a statement of the Executive Committee of the Board of Trustees of Good Samaritan Hospital and Medical Center - "Goals for Northwest Portland." This statement of 5/5/71 is attached to the minutes of this meeting.

Mr. Wessinger then distributed a copy of a letter dated May 11, 1971 to Mayor Terry D. Schrunk and a copy of Mayor Schrunk's letter of May 13, 1971 in reply. These two letters are attached to the minutes.

Mr. Beeman then spoke of the needs and goals of the Northwest District Association "The purpose of the Northwest District Association is to preserve and to improve the livability of Northwest Portland while protecting the personal (human) and property rights of individual citizens." He stated that Northwest Portland should first be a residential neighborhood; further, that at hearings before the Portland City Council, the Association explained the absolute necessity of an up-to-date comprehensive study of the area and that such a study should be made no later than to be simultaneous with any urban renewal study that might take place with reference to the hospital's comtemplated expansion study of the 15 block area of Northwest Portland in which the hospital plans to expand its facilities. He said further that this study had been authorized by the City Council and was presently being accomplished by the Portland Planning Commission in cooperation with members of the Association. This study is scheduled to be com pleted in January of 1972. Mr. Beeman stressed the importance of a coordinated effort by the Association and the Hospital to accomplish a plan for a well-planned neighborhood that would be for the good of the citizens as well as the hospital. He cited events that occured in the land acquisition program of Emanuel Hospital in relation to the rights of the people living in the area. He further stated that the human, or personal, rights of the people cannot be protected by any zoning mechanism; that planning for people is as necessary as planning for land use.

Mr. Wessinger introduced Mr. Chester Stocks, the Hospital's administrator, who, with the aid of charts, gave statistics concerning: numbers of patients, employees, students, medical staff and volunteers, indicating growth in all phases of the hospital's operations during the past five years, and the need for additional facilities to house the operations planned for the next ten years - up-dated surgical facility, addit ional research facilities, a physician's office building and a parking facility.

Mr. Wessinger then reviewed the needs and goals of the Hospital and Medical Center and distributed to those present a statement entitled, "Suggested Policy Positions Regarding Planning for Northwest Portland," Copy is attached to these minutes. He intro duced Dr. Robert Dow, chief medical officer of the hospital, who stressed the changing trends in medical care taking place now and expected in the next decade. Dr. Dow state that medical services were becoming more and more hospital oriented and stressed the new to advance hospital services and medical centers that would be commensorate with medical changes taking place all over the country.

The meeting was then thrown open to a discussion by those present. Ogden Beeman gave the Association's thanks to all present and said that he felt that the air had beer cleared somewhat, but that the people of the neighborhood must still be given assurance of the hospital's aims - they are not willing to give a square inch, much less 15 block. Reverend Thielen pointed out that if the hospital does not have actual plans for some time in the distant future, they might be able to outline their plans for the immediate future, say the next year or two.

Mr. Stocks replied that the hospital board feels that the most imminent need is parking; that a parking structure is being considered with a location in the hospital area. After that, a new surgical facility is considered necessary, and, following that a physician's building. In this connection, it appeared that if the hospital would mak known its immediate plans, the Association would be cooperative in seeking a solution that would possibly serve the hospital's goals and yet preserve the community's liveability.

An expression of the Association's side of the meeting also indicated that any planned closure of streets to accomplish the hospital's expansion might be detrimental to the community in that it would isolate the immediate surroundings and raise the danger to the inhabitants of robbery, rape, killings, etc. at night.

Dennis West brought up the question of what "hospital" really means and how few people are aware of this new meaning. Robert Dow answered that the "hospital" is, in fact, a "hospital and medical center." It was further pointed out by a member of the Association that it is the hospital's duty and obligation to the neighborhood in which it operates to keep the citizens aware of its plans and goals; this is not something that can be delegated to another organization.

An Association member asked if it were necessary for the hospital and medical cent to ask for a planning grant covering fifteen blocks in the area; this land seems much more than the hospital will need. In reply to this, a member of the Good Samaritan Board replied that the urban renewal planning grant request was only <u>sponsored</u> by the Hospital and would consider other institutions and facilities other than those of Good Samaritan; that the hospital would, not of itself, require fifteen blocks for expansion

It was further pointed out by a member of the Northwest District Association that since the time it was learned that the hospital had applied for a planning grant for th area, a great part of the community was actually becoming substandard because owners of properyy thought to be in the path of the urban renewal project discontinued maintenanc and care of the property because of misinformation or a lack of information as to what the hospital was actually going to do.

Considerable exploitation of property has taken place for the same reason with housing being bought for investment purposes. This latter situation has resulted in considerable absentee landownership.

At the conclusion of the discussion, Mr. Wessinger pointed out that the Hospital had not done as good a job within the neighborhood as it could have done. The Good Samaritan Hospital and Medical Center recognizes the concern of the Northwest District Association and will try to provide leadership in solving these problems by setting up a better system of communications.

The summer neighborhood small "group meetings" project of the NWDA has been an outstanding success. Many have combined their efforts to bring about the success of these meetings - the fifty-one hosts, Vera Katz, Charlotte Beeman, and Carol Edelman, who helped in setting up many meetings, and the forty persons who gave time to serve as group leaders and recorders.

44 - NORTHWEST DISTRICT ASSOCIATION - Monthly Meeting - Tuesday, August 17, 1971

The meeting was called to order at 7:50 by Lu Himes who restated the goals and objectives of the Association and expressed a hope that they could be turned into specific plans for the Norhtwest District Association.

Vera Katz announced that the Emanuel Displaced Persons Association was sponsoring a meeting at the Cascade Center at 7:30 on August 19 and that all people from any neighborhood organization would be welcome.

Bob Gettel, summer coordinator for the Association, reported the results of the 50 meetings held to date and gave an explanation of the job that he had performed. The "yellow report" was presented (attached to original minutes) which summarized the issues at each of the block meetings.

Lu Himes reported on progress in the corridor area where several houses have been condemned under code enforcement. Work was done by several in the organization to forestall eviction for at least 30 days. "We are working," Himes stated.

John Perry presented an explanation of the 2nd half of the preliminary goals report (attached to original minutes). He asked that the people present consider how these apply to them, the individual citizen. He further added that emergency relocation holds a high priority.

After an announcement by Lu Himes that there were men present who would be willing to escort ladies home after the meeting, slides were shown of traffic, housing and zoning conditions in various areas of the Northwest.

Discussion followed on the following issues:

- 1. Traffic and parking situations and re-routing of 18th and 19th Aves. and Burnside
- 2. Neighbors for Northwest Survival has gotten a bid of \$2300 \$2400 per house to move them from the Corridor Area.
- 3. Byron Smith expressed appreciation to the Board for its liaison with Good Samaritan's Board.
- 4. Whether or not to hold another meeting to discuss goals and objectives.
- 5. Impact study to slow Freeway progress.
 6. Constant concern of people on Thurman and Vaughn.
- 7. Alf Edelman you do not have to sell within the Corridor. Free legal assistance is available through legal aide.
- 8. Vera Katz prepare a brief snynopsis of what has been going on during the past month.
- Something will be done about the corridor area. 9.
- 10. John Perry - his report is not exactly what will be presented to the Council, but the plan must be finished by February 11, 1972.

The various Committee Chairmen were present to answer specific questions of those present. This was announced and the formal meeting adjourned.

The work of the Planning Committee this year has focused on setting goals and objectives and providing critques of the City Planning Commission's planning efforts. We've tried to be the Northwest citizen's counterpart to the Planning Commission - by stating what it is we want for our neighborhood for the next 20 years - the good things as well as the aspects we'd like to change - were set down. With the present assets as a starting point, we've tried to look ahead to see what <u>could</u> be the future of Northwest Portland.

Discussions dealing with the formulation of this idealized look-ahead occured at numerous meetings of four different but overlapping groups:

- 1. NWDA general membership meetings.
- 2. Planning Committee meetings.
- 3. Subcommittee meetings five subcommittees dealing with Zoning and Land Use (Howard Glazer, chairman), Housing (Alfred Edelman, chairman), Traffic (Lu Himes, chairman), Social Issues (Dennis West, succeeded as chairman by Gloria Osmont) and Business Activities (Edgar Storms, chairman).
