

# 2022-23 Residential Curbside Collection Rate Review Planning and Sustainability Commission Hearing

May 10, 2022

## **RATE REVIEW PROCESS**

#### **Ongoing Monitoring and CPA Review**

Throughout the year, haulers file a variety of reports with BPS detailing customer counts, quarterly revenues, and tons of recycling, yard debris/food scraps and garbage collected.

Residential franchisees file a Detail Cost Report (DCR) documenting their revenues and expenses for the previous calendar year. BPS contracts with a CPA firm to review the DCRs from a random sample of haulers (representing at least 75% of the customer base) to ensure all expenses are allowable.

#### **Calculation of Rates**

The allowable expenses incurred during the previous calendar year form the basis for the rates in the upcoming fiscal year. Projected costs are added looking forward through June 2023. It is important to note that inflation and other cost projections are applied to the actual costs of providing service and not across the board to the existing rates. In this way, reduced operating costs can mitigate the effect of upward pressures on the rates.

Rates are designed to allow haulers the opportunity to recover the per customer composite cost of providing service plus a return equal to 9.5% of revenues. Rates also include a 5% franchise fee paid to the City.

## **KEY COST FACTORS**

#### **Metro Tipping Fee Increases**

Fees charged to unload material at Metro's transfer stations will increase seven percent.

- Garbage tipping fee will increase from \$115.15 to \$123.29/ton.
- Yard Debris / Food Scrap tipping fee will increase from \$77.99 to \$82.38/ton.

## **Projected Inflationary Increases**

- <u>Labor hours</u> are adjusted using a weighted average of union contract wage increases and the general cost-of-living increase. Adjustments for wages, health & welfare, and pension are projected at about five percent.
- <u>Fuel costs</u> for biodiesel and Compressed Natural Gas (CNG) are anticipated to increase in the upcoming rate year. The average projected increase is about 18 percent.
- <u>Inflation</u> is forecast to be around 7 percent on an annualized basis.

#### **Previous Investments in Cleaner Trucks**

Haulers invested in new trucks to comply with BPS' Clean Fleet requirement. Reduced depreciation for those purchases continues to offset other anticipated cost increases.

#### **Improved Recyclable Materials Markets**

When global recycling markets shifted in 2017, lower prices and higher sorting costs resulted in significant charges to haulers for processing recycling. This year, demand for recyclable materials has improved, resulting in lower processing charges. For 2022-23, recycling processing charges are projected to be 70 percent lower than what was anticipated for the 2021-22 rates.

## **TERRAIN FEE**

The terrain fee is applied in areas of Portland's hillier west side where low street connectivity, larger lots, and narrow, windy roads increase the costs to collect garbage, recycling, and composting. Increases in fuel and wages necessitate a \$0.30, or seven percent, bump in the terrain fee to \$4.85 per month.


#### **Residential Waste Collection Rates Over Time**

Portland residents and Portland haulers are each doing their part to keep garbage and recycling rates low. Portland residents continue to recycle and compost most of their waste, saving expensive tipping fees at the transfer station. Portland haulers continue to find operational efficiencies and provide high-quality service at a price that beats inflation.









## **Customer Subscription Trends**

At the end of 2011, Portland added weekly collection of food scraps in the composting bin and switched garbage collection to every-two-weeks. Many Portlanders loved having double the yard debris service and the ability to put their food scraps to productive use. The program change also reduced garbage capacity and over time, some households have found they need a bigger garbage bin. While BPS encourages waste reduction and recycling to meet Portland's climate goals, we also support residents in choosing the garbage service level that best meets the needs of their household.
