ORDINANCE No.

An Ordinance creating one limited term Secretarial Clerk I (0220) position within the Human Resources Bureau, AU 682, Training and Employment Division, effective February 3, 1982, impacting the Budget in the amount of \$5,100, to be charged to the Administrative Cost Pool, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. One limited term position of Secretarial Clerk I (0220) is required by the Human Resources Bureau, Training and Employment Division, Management Information Systems Unit.
- 2. The position is necessary due to conversion of the participant payroll system within TED's Management Information Systems Unit and the need to run parallel systems prior to summer youth programs.
- 3. The position to be created has been classified by and has the approval of Civil Service.
- 4. Funds for salary and benefits are available for this position within the FY 81-82 Budget, AU 682.
- 5. It is therefore appropriate that one limited term Secretarial Clerk I (0220) position be created.

NOW, THEREFORE, the Council directs:

- a. One (1) limited term Secretarial Clerk I (0220) position is created within the Human Resources Bureau, AU 682, Training and Employment Division, effective February 3, 1982, at the salary rate in accordance with the current compensation plan of the City of Portland.
- Section 2. The Council declares that an emergency exists, because delay in the enactment of the Ordinance will result in constraints being placed on the Management Information System; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
