## ORDINANCE No. 152834

An Ordinance authorizing the Commissioner of Public Safety and City Auditor to execute on behalf of the City a Mutual Release of all claims arising out of the contract dated January 15, 1977 with John H. Thodos for architectural services in connection with the St. Johns Indoor Tennis Court project; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. On November 15, 1977 the City and John H. Thodos (Thodos) entered into an Agreement for Thodos to provide the City with architectural services for the St. Johns Indoor Tennis Court project.
- 2. A dispute arose between the City and Thodos regarding the performance of the Agreement for architectural services. The City claims Thodos owes it \$43,472.05 because the sole bid based on Thodos' work exceeded the estimated cost of the project. Thodos claims the City owes him \$26,543.95 for services performed under the Agreement. Because of the uncertain outcome of any litigation involving the respective disputed claims of the parties and the expense of such litigation the Commissioner of Public Safety and the City Attorney's Office recommend that a proposed Mutual Release of these claims be approved.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner of Public Safety and the City Auditor be authorized to execute a Mutual Release, in the form of which a copy, marked Exhibit A, is attached to the original only of this Ordinance, of all claims between the City and Thodos arising out of the January 15, 1977 Agreement for architectural services.
- Section 2. The Council declares that an emergency exists because the agreement of the parties to settle these claims should be carried out as soon as possible; therefore this Ordinance shall be in force and effect from and after its passage by the Council.
