

ORDINANCE No. 152856

An Ordinance authorizing the donation of one surplus fire truck to the Portland Rainmakers, Inc., P.O. Box 14345, Portland, Oregon 97214, for use in civic promotional activities notwithstanding the provisions of Section 5.36.010 of the Code of the City of Portland, and declaring an emergency.

Section 1. The Council finds:

1. That the Bureau of Fire has declared surplus and turned over to the Property Control Warehouse one 1952 four wheel drive fire truck (pumper), Model #F1250T, City inventory #34509.
2. That the Portland Rainmakers, Inc. have requested the City to donate this fire truck to their organization for use in civic promotional activities in Portland and throughout Oregon.
3. That the donation of this pumper to the Portland Rainmakers, Inc. will serve a useful purpose.

NOW, THEREFORE, The Council directs:


- a. The Purchasing Agent is hereby authorized to donate one 1952 four wheel drive fire truck (pumper), Model #F1250T, City inventory #34509 from City surplus property, to the Portland Rainmakers, Inc., P.O. Box 14345, Portland, Oregon 97214, notwithstanding the provisions of Section 5.36.010 of the City Code.

Section 2. The Council declares that an emergency exists in order that there may be no delay in providing authority for the donation mentioned in Section 1 hereof; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
