## ORDINANCE NO. 152860

An Ordinance fixing a public hearing for March 10, 1982, at 9:30 a.m., in the Council Chamber of the City Hall, on the question of withdrawal from Gilbert Water District of territory located in SE part of City S of SE Claybourne & E of SE 134th, more particularly: TL 1 of Lot 28 of Lamargent Park No. 2, annexed to the City of Portland, authorizing the City Auditor to publish and post notices and expend money therefor, and declaring an emergency.

## The City of Portland ordains:

- 1. Tax Lot 1 in Lot 28, Lamargent Park No. 2, Section 23, 1S, 2F., W.M. has been annexed to the City by Portland Metropolitan Area Local Government Boundary Commission Final Order No. 1711, effective May 21, 1981.
- 2. It is appropriate to withdraw said area from Gilbert Water District pursuant to ORS 199.510(b), 222.520 and 222.524.

## NOW THEREFORE, the Council directs:

a. A public hearing shall be heard on March 10, 1982, at 9:30 a.m., in the Council Chamber of the City Hall, at which time objections shall be heard regarding withdrawal from said district of the following-described property.

Beginning at the northwest corner of Lot 30, Lamargent Park No. 2; thence south along the west line of said Lot 30, a distance of 188 feet; thence west on a line parallel to SE Claybourne Street a distance of 100 feet, more or less; thence northerly, parallel to the west line of said Lot 30, to a point on the north line of Terraboone subdivision (recorded March 29, 1978, in Book 1208 at Page 95, Multnomah County Records) extended east, said point is the true point of beginning; thence continuing northerly on said line parallel to Lot 30 to a point lying 130 feet south of the center line of said Claybourne Street; thence westerly 80 feet to a point; thence southerly to the north line of said Terraboone subdivision; thence easterly along said north line 80 feet to the true point of beginning, containing .0689 acres, more or less.

- b. The City Auditor is authorized to publish notice of the date, time, place and purpose of said hearing once each week for two successive weeks prior to the hearing in the City official newspaper, and shall cause notices of said hearing to be posted in four public places in the City for a like period.
- c. The City Auditor is authorized to expend money for such publication as may be needed, chargeable to the appropriation for such advertising.

- d. The City Auditor shall notify said district of said hearing
- Section 2. The Council declares that an emergency exists because the hearing must be held without undue delay on the question of withdrawal of said property from said district; therefore this ordinance shall be in force and effect from and after its passage by the Council.
