ORDINANCE NO. 152873

An Ordinance authorizing a compromise settlement in the amount of \$10,000 to be paid to Raymundo R. Perez for personal injury sustained on August 23, 1978, subject to the approval of the Multnomah County Circuit Court, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Raymundo R. Perez, who resides at 834 SW 15th Street, Portland, Oregon, has filed a lawsuit for \$115,690.75 for personal injuries sustained on August 23, 1978.
2. The claim has been investigated by the City's Risk Management Division and the City Attorney's Office and it appears that there is a substantial risk that the City and the named officers might be find liable and it is prudent to settle the claim in order to avoid full liability therefore and further costs of defense and litigation.
3. The City Attorney recommends that the claim be settled for \$10,000, subject to claimant providing the City with a release in a form to be approved by the City Attorney.
4. Pursuant to ORS 30.290, the settlement of this claim is subject to the approval of the Multnomah County Circuit Court.

NOW, THEREFORE, The Council directs:

- a. Subject to the approval of the Multnomah County Circuit Court pursuant to ORS 30.290, the Mayor and Auditor are authorized to draw and deliver a warrant in the amount of \$10,000 made payable to Raymundo R. Perez and his attorneys, Jerome E. LaBarre and Daniel F. Vidas, as settlement in full of all claims for damages upon receipt of a release approved by the City Attorney.


- b. The Bureau of Risk Management will execute a payment authorization in the amount set forth in paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
