

ORDINANCE No. 152882

An Ordinance amending Contract #19502 between the City of Portland and Ames Associates, Inc., increasing the amount of the contract by \$8,400, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that:

1. Ordinance #151659 passed on June 3, 1981 approved Contract #19502 with Ames Associates, Inc. to provide services to the Housing & Community Development program (HCD).
2. These services included assisting the HCD Citizens Advisory Task Force with the preparation of the three year plan and citizen participation plan.
3. At the request of the Task Force, the original deadline has been extended, additional meetings have been scheduled, and additional drafts of the plan have been prepared.
4. Due to this expanded schedule and workplan, additional funding is needed to cover the consultant's costs.
5. Contract #19502 needs to be amended by increasing the total amount to \$43,400, an increase of \$8,400.
6. Appropriation transfer of \$8,400 for this contract is included in the Bureau of Community Development in the Second Quarter Budget Ordinance.

NOW, THEREFORE, the Council directs:


- a. That Contract #19502 between Ames Associates, Inc. and the City of Portland hereby is amended by increasing the total amount by \$8,400.
- b. The Mayor and Auditor hereby are authorized to draw and deliver warrants for said contract.

Section 2. The Council declares an emergency exists in order that the HCD Three Year Plan and the Citizens Participation Plan may not be delayed; therefore this ordinance shall be in force and effect from and after its passage by Council.
