ORDINANCE No. 152892

An Ordinance authorizing the Purchasing Agent to call for bids for purchase of Belt Filter Presses for the Bureau of Sanitary Engineering, authorizing a contract, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Sanitary Engineering requires Belt Filter Presses be purchased for installation under a future contract.
- 2. That funds for the purchase of this equipment are available in the 1981-82 budget with additional funds budgeted in the 1982-83 budget.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall advertise for bids using specifications filed in his office.
- b. The Commssioner of Public Works and the Auditor hereby are authorized to execute a contract with the responsible bidder for purchase of the equipment described in Section 1 hereof in accordance with specifications filed in the Purchasing Agent's office.
- c. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1981-82 budget; Sewage Disposal Fund, Bureau of Sanitary Engineering, Treatment Plant and Pump Station Engineering Division, RU 149, Object Code 630, Improvements; when demand is presented, approved by proper authorities.
- Section 2. The Council declares that an emergency exists because a delay in proceeding with the purchase may result in additional expense, and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
