

# ORDINANCE No. 152895

An Ordinance authorizing the appointment of Willis White to the position of Public Works Maintenance Director in the Bureau of Maintenance at the second year salary rate, effective March 1, 1982, and declaring an emergency.

The City of Portland ordains:

1. Willis White has been selected to fill the position of Public Works Maintenance Director at the Bureau of Maintenance.
2. Mr. White's level of knowledge and experience qualify him for the second year salary rate.
3. The necessary appropriation is available within the Bureau budget.

NOW, THEREFORE, the Council directs:


- a. The appointment of Willis White to the position of Public Works Maintenance Director in the Bureau of Maintenance is hereby authorized at the second year salary rate as set forth in the current Compensation Plan of the City of Portland, effective March 1, 1982.

Section 2. The Council declares that an emergency exists in order that Willis White be fairly compensated without delay; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
