

ORDINANCE No. 152906

AN ORDINANCE amending Section 31.12.100, Adoption of the Oregon administrative rules, fire marshal, Chapter 837, to update the incorporation by reference in the Code of the City of Portland to include those rules effective as of February 1, 1982, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That the City, in order to maintain its exempt status, as a jurisdiction, from the purview of certain state statutes, which thereby provides greater local control of fire prevention practices, is required to adopt and incorporate the current administrative rules of the state fire marshal as a part of the City's code.
2. That the code provision providing for such adoption and incorporation of said rules needs to be updated to reflect rule changes of the state fire marshal.

NOW, THEREFORE, the Council directs:

- a. That Section 31.12.100, Adoption of the Oregon administrative rules, fire marshal, Chapter 837, is hereby amended to read as follows:

31.12.100 Adoption of the Oregon administrative rules, fire marshal, chapter 837. (a) For the purpose of exempting the City of Portland from such regulations in the statutes as are administered by the state fire marshal and from his rules and regulations, the Oregon administrative rules, fire marshal, Chapter 837, effective as of February 1, 1982, is hereby adopted and incorporated in this title by reference.

(b) For the purpose above stated, three sets of the Oregon administrative rules, fire marshal, Chapter 837 shall be filed as follows: one with the city auditor, one with the fire marshal, and one with the bureau of buildings, and kept available for public reference.

ORDINANCE No.

Section 2. The Council declares that, in order to immediately protect and preserve the public health, safety and welfare, an emergency exists, and this ordinance shall be in force and effect from and after its passage by the Council.
