ORDINANCE NO. 152907

An ordinance amending Section 20.20.010 of the City Code to revise rates charged at municipal golf courses, establishing an effective date of March 1, 1982, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Golf fund is an enterprise fund managed by the Bureau of Parks, which must be self-sufficient and generate sufficient revenues to cover all operating expenses and to provide for replacement and improvement of its physical assets on a planned basis.
- 2. A five-year projection of revenue and expenditures, prepared by the Bureau of Parks, indicates the need for periodic fee increases to maintain said self-sustaining condition.
- 3. In line with this projection, the Commissioner-in-Charge recommends the following rate changes to be effective March 1, 1982, to cover anticipated operating expenses and capital outlay requirements.

NOW, THEREFORE, the Council directs:

a. Section 20.20.010 of the City Code is amended to read as follows:

20.20.010 Playing Rates. (a) The following rates shall be charged and collected for the privilege of playing golf at the Eastmoreland, Rose City, Progress Downs, and West Delta Golf Courses:

For a 9-hole ticket on weekdays	\$4.00
For a 9-hole ticket on Saturdays, Sundays and holidays	\$5.00
For an 18-hole ticket on weekdays	\$7.50
For an 18-hole ticket on Saturdays, Sundays and holidays	\$9.00

(Holiday rates shall be charged on these days: New Year's Day, President's Day, Memorial Day, Independence Day, Labor Day, Veterans' Day, Thanksgiving Day, and Christmas Day. In the event the holiday falls on a weekend, these rates will apply only on the day the holiday actually falls and not on the Friday preceding nor the Monday following.)

b. For players who hold a valid membership in the City Junior Golf Club and who have passed their ninth birthday, but who have not passed their 18th birthday, the rate for each 9 holes shall be \$2.00.

The "junior" rate will not apply on Saturdays, Sundays or holidays before 3:00 p.m. or after 4:00 p.m. on weekdays between April 1 and September 30.

c. For college golf team members during practice rounds or inter-collegiate tournament competition only, the rate for 9 holes shall be \$2.00.

For Portland Interscholastic League high school golf teams during league matches No Charge. Only the following schools have playing privileges for their golf teams on City golf courses: Portland Interscholastic League high schools, Central Catholic High School, St. Mary's High School, and Portland Community College.

d. For senior citizens 65 years or older, with proper proof of age, the rate for 9 holes or less shall be \$2.00

A special 6-month ticket may be purchased for the period October 1 through March 31, and the cost of said ticket shall be \$100.00.

The senior citizen rates will not be valid on Saturdays, Sundays or holidays before 3:00 p.m. or after 4:00 p.m. on weekdays between April 1 and September 30.

Any citizen resident 85 years or older may play without fee on weekdays at hours for senior play.

- g. The following rates shall be charged for the privilege of using the facilities of the Eastmoreland Driving Range:

For	each	bucket	of	approximately	18	golf	balls	\$ \$1.00
For	each	bucket	of	approximately	50	golf	balls	\$ 2.00
For	each	bucket	of	approximately	100	golf	balls	\$ 3.00

- Section 2. The fee revision authorized by this ordinance shall be effective March 1, 1982.
- Section 3. The Council declares that an emergency exists because delay in effectiveness of the revised golf rates as outlined in Section 1 hereof will unnecessarily deprive the City of the benefits of the increased fees; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
