

# ORDINANCE No. 152911

152911

An Ordinance amending Ordinance No. 152833, being an ordinance assessing upon certain property the cost of repairing and constructing sidewalks, curbs and driveways in front thereof for the one-month billing period ended November 30, 1981, by correcting the legal description of one property, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 152833 assessed Oakdale Addition, Block 2, Lot 28, \$240.24 for the repair and construction of sidewalks, curbs and driveways in front thereof for the one-month billing period ended November 30, 1981, and entered in City Lien Docket Book 125, Page 307.
2. The legal description of the property which benefits from this work is Oakdale Addition, Block 3, Lot 28.

NOW THEREFORE, the Council directs:

- a. Ordinance No. 152833 is amended by correcting the legal description from Oakdale Addition Block 2, Lot 28 to, Oakdale Addition, Block 3, Lot 28.

Section 2. The Council declares that an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
