

ORDINANCE No. 152946

An Ordinance amending Ordinance No. 152849, being an ordinance assessing upon certain property the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended November 30, 1981, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 152849 passed by the Council February 17, 1982 assessed Kenilworth, Block 15, East half of Lots 15 & 16, \$103.95 for the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended November 30, 1981, and entered in the City Lien Docket Book 125, Page 308.
2. This lien was paid as an invoice and should not be included in the assessment.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 152849 is amended by cancelling against Kenilworth, Block 15, East half of Lots 15 & 16 of \$103.95 and reducing the total assessment of \$3,338.69 to \$3,234.74.

Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
