

ORDINANCE No. 152947

An Ordinance amending Ordinance No. 152833, being an ordinance assessing upon certain property the cost of repairing and constructing sidewalks, curbs and driveways in front thereof for the one-month billing period ended November 30, 1981, by cancelling the assessment for Oakdale Addition, Block 2, Lot 19, and reducing the total assessment by \$95.81, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 152833 passed by Council February 10, 1982 assessed Oakdale Addition Block 2, Lot 19, \$95.81 for the repair and construction of sidewalks, curbs and driveways in front thereof for the one-month billing period ended November 30, 1981, and entered in City Lien Docket Book 125, Page 307.
2. This lien was paid as an invoice and should not be included in the assessment.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 152833 is amended by cancelling the assessment of \$95.81 against Oakdale Addition, Block 2, Lot 19 and reducing the total assessment of \$14,556.20 to \$14,460.39.

Section 2. The Council declares that an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
