## ORDINANCE No. 152971

An Ordinance authorizing the Purchasing Agent to call for bids to construct the project "Repair of Washington Park Roads" for the Bureau of Parks, authorizing a contract, authorizing the drawing and delivery of warrants and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Parks requires that portions of S.W. Knights Boulevard in Washington Park be repaired.
- 2. The funding for this specific project was approved by the Council in the FY 1981-'82 Budget of the Bureau of Parks.
- 3. Construction documents have been prepared for bid purposes.

NOW, THEREFORE, The Council directs:

- a. The Purchasing Agent shall advertise for bids using drawings and specifications filed in his office, and in the event that no satisfactory bid is received, shall readvertise on the same basic specification until a satisfactory bid is received.
- b. A contract is authorized with the most favorable bidder as designated by the Council.
- c. The Mayor and Auditor hereby are authorized to draw and deliver warrants chargeable to the FY 1981-'82 Budget of the Bureau of Parks (BUC 13350086/630), when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists because a delay in proceeding with the road repair project will unnecessarily deprive the City of benefits of completion of the contract at an early date; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
