## ORDINANCE NO. 152979

An Ordinance adopting the Self-Help Demonstration Program for Housing and Community Development funding; transferring \$25,000 within the Housing and Community Development fund; and declaring an emergency.

The City of Portland ordains:

#### Section 1. The Council finds that:

- During the 1981-82 budget hearings Council directed the Bureau of Community Development to develop a program for funding neighborhood based self-help demonstration projects and to submit to Council an Ordinance adopting a demonstration program and appropriating HCD funds.
- 2. The Bureau of Community Development issued a staff report defining the guidelines and criteria of the demonstration program.
- The Bureau of Community Development solicited self-help proposals from the community based on the criteria stated in the staff report.
- 4. Fourteen proposals were submitted from various organizations requesting funds for self-help projects.
- 5. Upon review and evaluation, four of the proposals best meet the criteria established and will be processed based on the following.
- 6. The proposals will be reviewed by U.S. Department of Housing and Urban Development staff to verify eligibility.
- Bureau of Community Development staff will meet with the applicants selected to verify costs and refine the scope of work and timeline.
- 8. Contracts will be prepared between the Housing and Community Development and the applicants for a total amount not to exceed \$25,000.
- The selected applicants will agree to submit to the Bureau of Community Development each and every month a written progress report and a statement of budgeted and actual expenditures.
- 10. \$25,000 needs to be transferred in the Housing and Community Development appropriation unit for funding this program in FY 81-82.

NOW, THEREFORE, the Council directs that:

- a. The Self-Help Demonstration Program be approved.
- b. The City 1981-82 Budget be amended as follows:

Section 2. So that there will be no delay in implementing the Self-Help Demonstration Program, the Council declares that an emergency exists and this Ordinance shall be in force and effect from and after its passage by Council.
