ORDINANCE No. 152980



An Ordinance authorizing ratification of a contract with N.C.R. Corporation to furnish a Programmable Remittance Processing System to the Bureau of Water Works, transferring \$96,434 within the Water Fund, authorizing the drawing and delivery of a warrant/s and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. N.C.R. Corporation was the lowest responsible bidder for a Programmable Remittance Processing System for the Bureau of Water Works.
- 2. Award of a contract to said bidder was approved by the City Council on October 21, 1981, by Report to Council.
- It is necessary to transfer \$96,434 within the Water Fund from Contingency to Computer Services Section.

NOW, THEREFORE, the Council directs:

- a. That a contract with N.C.R. Corporation for the item described in Section 1 hereof is ratified.
- b. \$96,434 is transferred within the Water Fund from Contingency, Object Code 710, BUC 17500155 to Computer Services Section, Object Code 640, BUC 18000709, Project No. 4800.
- c. The Mayor and Auditor hereby are authorized to draw and deliver warrants chargeable to the 1981-82 Budget, Water Fund, Computer Services Section, BUC 18000709, Object Code 640, when demand is presented, approved by the proper authorities.
- Section 2. The Council declares that an emergency exists because a delay in proceeding with the purchase may result in additional expense, and will unnecessarily deprive the City of the benefits of the contract completion at an early date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
