Dear Mr. Yerkovich - Re: Uniform for Bureau of Police

Reference is made to the Transitory Period on the Contract we now serving for the Bureau of Police, which expires on June 30, 1982, and requiring the Vendor to notify the City within sixty (60) days of that date.

Please be advised that we wish to continue with the Contract for an additional year from June 30, 1982, under the following arrangements:

We would continue to supply items No. 1, #1A, #5A #7A and #11, 11A, at the present Contract Prices, as we have ample stocks of these items on hand to continue good service until June 1983.]

However, in the third year, we must go into the market for fabrics, etc., at costs higher than we encountered in purchasing for the original contract, and therefore would require an increase for the third year of ten percent (10%) on the following items:

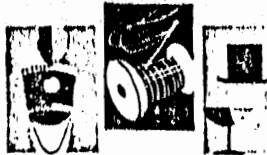
#2, #3, #4B, #5B, #6, #7B, #7C, #8A, #8B, #9, #10 and #11. To simplify and clarify, we have noted on the attached page the prices now in effect to June 30, 1982 and how they would be affected for the third year.]

We are sure that Bid Requests for a two year period from June 1982 would bring higher costs throughout the entire uniform program. So, we really feel this proposal represents a real savings for the City of Portland in the third year of the contract.

We hope that a decision can be made soon, as we have figured the costs of items that must be produced in time for the third year's start, on today's market, and any delay might escalate our costs because of today's inflation.

An Ordinance extending Contract No. 19047 for furnishing Police Uniforms, Dress and Insignia, with Nudelman Brothers Incorporated, through June 30, 1983, authorizing the drawing and delivery of warrants.

The City of Portland ordains:

Section 1. The Council finds:

1. The Council finds Contract No. 19047 with Nudelman Brothers Incorporated for furnishing Police Uniforms, Dress and Insignia, to the Police Bureau of the City from September 1, 1980 through June 30, 1982, was awarded after a call for bids.
2. Specifications call for option to renew contract for an additional one (1) year period.
3. Contractor, by letter dated February 10, 1982 to the City of Portland, attached to Original Only as Exhibit "A" and by this reference made a part hereof, has offered to extend said contract under same terms and under the same conditions of the existing contract through June 30, 1983, commencing July 1, 1982.
4. The Purchasing Agent has reviewed the request for extension by Nudelman Brothers Incorporated and recommends extension of the contract.
5. The Police Bureau concurs and recommends extension of contract - Exhibit B.
6. That it is advantageous to the City to extend said contract for an additional year.

NOW, THEREFORE, the Council directs:

- a. Contract No. 19047 with Nudelman Brothers Incorporated, 440 SW Fourth Avenue, Portland, Oregon 97204, is hereby extended through June 30, 1983, commencing July 1, 1982, under terms and conditions contained in said contract.


