#### ASSIGNMENT OF LEASE

This agreement made and entered into this day of 1982, by and between The City of Portland, a municipal corporation ("City"), Martin W. Dodge and A. Raymond Dodge ("Assignor"), and Terry Ashton, an individual ("Assignee")

#### WITNESSETH:

WHEREAS, Assignor now leases from City certain premises

- 1. Assignor assigns to Assignee all his right, title and interest as Lessee under that certain Lease Agreement between the City and Assignor dated October 31, 1980, respecting the ground floor store-room containing approximately 1,556 square feet located at Lots 1, 2, 3, 4, 5, 6, 7, and 8 of Block 49, Portland, more commonly known as Morrison Park East.
- 2. Assignee assumes all rights and obligations of Lessee under said lease and agrees to be bound by its terms and conditions and any modifications hereof contained herein.
- 3. The City expressly approves this assignment and releases Assignor from all further liability under said lease.

- 5. All rent and other charges owing City under said lease are paid through February, 1982. All sums owned by Assignor to City under said lease have been paid in full, and all covenants to be performed by Assignor under said lease have been performed or their performance is hereby waived.
- 6. It is agreed that the expiration date of said lease pursuant to paragraph 1(A) thereof is February 28, 1987.
- 7. Assignee has inspected the premises and accepts them "as is".
- 8. The permitted use of the premises pursuant to paragraph 3 of said lease shall be display and retail sales of micro computers and related hardware. Assignee shall do business under the name "Computerland of Multnomah County."

### ORDINANCE No. A. M. M. M.

An Ordinance authorizing an assignment of the lease agreement with Martin W. Dodge and A. Raymond Dodge, individuals, to Terry Ashton, an individual, for space in Morrison Park East for the remaining term of six years, for operation of a retail store, and declaring an emergency.

The City of Portland ordains:

### Section 1. The Council finds:

- 1. The Portland Development Commission entered into a lease agreement with Martin W. Dodge and A. Raymond Dodge on October 31, 1980, effective February 15, 1981.
- 2. Martin W. Dodge and A. Raymond Dodge have relinquished possession of the premises, and rent has been paid to the City according to the terms of the agreement.
- 3. Resolution No. 32595, passed by the Council on January 23, 1980, accepted jurisdiction and control of the Morrison Park East facilities from Portland Development Commission.
- 4. Martin W. Dodge and A. Raymond Dodge wish to assign their interest in the agreement for lease of retail space located at 327 S. W. Morrison to Terry Ashton. Terms and conditions are advantageous to the City.

a. The Auditor and Commissioner of Public Utilities are authorized to execute an assignment of lease providing for the assignment of the above described lease to Terry Ashton, an individual, from Martin W. Dodge and A. Raymond Dodge, individuals, 12070 N. W. Kathleen Drive, Portland, Oregon 97229, such agreement to be substantially in conformance with Exhibit A which is attached to the original only hereof and by this reference made a part.

### ORDINANCE No.

Section 2. The Council declares that an emergency exists because it is necessary to proceed at once with an agreement for lease of retail space in the Morrison Park East parking garage in order to maintain the greatest income to the City; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
