An Ordinance authorizing the acceptance of reimbursements for the nutrition program in the amount estimated at \$266,318 from the United States Department of Agriculture through the State Senior Services Division; Human Resources Bureau; AU 380; Area Agency on Aging for the period July 1, 1981 through June 30, 1982, amending the FY 81-82 City Budget by increasing appropriations and declaring an emergency.

The City of Portland Ordains:

Section 1. The Council finds:

- 1. Pursuant to Ordinance No. 151654, the City approved the fiscal year 1981-82 Annual Plan of Action which includes the provision for nutrition services for the elderly in Portland/Multnomah County for the period July 1, 1981, through June 30, 1982.
- 2. The Older Americans Act of 1965 as amended, provides for the United States Department of Agriculture to reimburse a portion of the cost of meals served under the elderly nutrition program.
- 3. Contracts with Loaves and Fishes Centers, Inc., Mittleman Jewish Community Center, Japanese Ancestral Society, Committee of Spanish Speaking People of Oregon, and Urban Indian Council, and a Letter of Agreement with Portland Action Committees Together were executed for the period July 1, 1981 through June 30, 1982 to provide elderly nutrition services for which United States Department of Agriculture meal reimbursements would be allowed.
- 4. Pursuant to notification by the United States Department of Agriculture, these funds are now available in the estimated amount of \$266,318 for reimbursement to the nutrition service providers.
- 5. Should said funds from the Department of Agriculture be insufficient to cover the requests made by the service provider, the City has no liability regarding the replacement of such funds.
- 6. No indirect costs are allowed.
- 7. No match is required.
- 8. It is therefore appropriate for the Mayor and City Auditor to accept on behalf of the City reimbursements for the nutrition program in the amount now estimated at \$266,318 from the United States Department of Agriculture through the Senior Services Division; Human Resources Bureau; AU 380; Area Agency on Aging for the period July 1, 1981 through June 30, 1982, thereby amending the FY 81-82 City Budget by increasing appropriations.

#### NOW THEREFORE, the Council directs:

- a. The Mayor and the City Auditor are hereby authorized to accept on behalf of the City, reimbursements for the nutrition program in the amount now estimated at \$266,318 from the United States Department of Agriculture through the Senior Services Division; Human Resouces; AU 380; Area Agency on Aging for the period July 1, 1981 through June 30, 1982.
- b. The FY 81-82 City Budget is hereby amended as follows:
