ORDINANCE NO. 1586833

An Ordinance transferring \$34,519 from the Sewage Disposal Fund to the General Fund and \$146,949 within the General Fund from General Fund Operating Contingency to Special Appropriations #400 to pay for addiitions and rework to The Portland Building that are indicated in Change Orders Nos. 24 and 25, and authorizing drawing and delivery of warrants.

The City of Portland ordains:

Section 1. The Council finds:

- 1. On May 9, 1980, the City entered into an agreement (Contract No. 18673) with the City of Portland, Oregon Public Buildings Corporation (PBC) regarding the financing, design, construction, and furnishing of a City office building.
- 2. On December 9, 1981, by Ordinance No. 152605, said contract was amended to provide that if requested by the City, PBC will approve change orders for which the City will bear the full cost.
- 3. On January 28, 1982, PBC presented, among other things, a list of additions and rework that will require funding by the City, said additions and rework having been requested by the City as follows:
