

## ORDINANCE No. 153034

An Ordinance repealing Chapters 8.56, 8.60 and 8.64 of Title 8, Health and Sanitation, of the Code of the City of Portland, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Chapter 8.56 of the Code of the City of Portland relates to automatic dry cleaning establishments; Chapter 8.60 of the Code of the City of Portland relates to secondhand bedding, clothing, textiles, rags and rugs; and Chapter 8.64 of the Code of the City of Portland relates to fumigation;
2. The Multnomch County Health Department, which administers Title 8 of the Code of the City of Portland, has determined that there is no present need for health regulations in the areas covered by Chapters 8.56, 8.60 and 8.64 of the Code of the City of Portland;
3. It is appropriate and in the public interest that Chapters 8.56, 8.60 and 8.64 of the Code of the City of Portland be repealed.

NOW, THEREFORE, the Council directs:

- a. The following chapters of Title 8, Health and Sanitation, of the Code of the City of Portland, are hereby repealed: Chapter 8.56, Automatic Dry Cleaning Establishments; Chapter 8.60, Secondhand Bedding, Clothing, Textiles, Rags and Rugs; and Chapter 8.64, Fumigation.

Section 2. The Council declares that an emergency exists because the delay in the enactment and effectiveness of this ordinance may cause confusion as to the regulation of dry cleaners, secondhand bedding, clothing, textiles, rags, rugs, and fumigation; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
