An Ordinance authorizing a contract with Union Floor Company in the amount of \$37,200.00 to furnish and install maple flooring for the Stage Floor Replacement Project at the Civic Auditorium, authorizing the drawing and delivery of warrant (s) and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Civic Auditorium stage floor, due to heavy use, is badly worn and cracked and should be replaced.
- 2. The Civic Auditorium 1981-82 FY approved budget contains the appropriation for replacement of the existing Auditorium stage floor.
- 3. Union Floor Company was the lowest responsible bidder for the stage floor replacement project for the Civic Auditorium with a bid amount of \$37,200.00. This amount includes two added alternates to replace decking on stage elevators and to salvage 2,000 sq.ft. of existing floor for reuse in the rehearsal hall.
- 4. The Commissioner of Public Affairs and the Civic Auditorium Manager have reviewed and approved the bid document submitted by Union Floor Company, and recommend the awarding of a contract.
- NOW, THEREFORE, the Council directs:
 - a. The Mayor and the Commissioner of Public Affairs hereby are authorized to execute a contract with Union Floor Company, 4244 S.E. Belmont, Portland, Oregon 97205, described in Section 1 hereof in accordance with specifications filed with the Purchasing Agent on March 5,1982.
 - b. The Mayor and the Auditor hereby are authorized to draw and deliver warrant (s) in the amount of \$37,200.00 to Union Floor Company, chargable to the 1981-82 Budget; Auditorium Fund, Civic Auditorium, 33300051/630, when demand is presented, approved by the proper authorities.

ORDINANCE No.

Section 2. The Council declares that an emergency exists because a delay in proceeding with the purchase may result in additional expense, and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
