

ORDINANCE No. 153066

An Ordinance authorizing the appointment of Micki Cross to the position of Secretarial Assistant in the Bureau of Civic Auditorium at the top salary rate, effective April 19, 1982, and declaring an emergency.

The City of Portland ordains:

1. Mickie Cross has been selected to fill the position of Secretarial Assistant at the Bureau of Civic Auditorium.
2. Mrs. Cross's level of knowledge and experience qualify her for the top salary rate.
3. The necessary appropriation is available within the Bureau budget.

NOW, THEREFORE, the Council directs:

- a. The appointment of Micki Cross to the position of Secretarial Assistant in the Bureau of Civic Auditorium is hereby authorized at the top salary rate as set forth in the current Compensation Plan of the City of Portland, effective April 19, 1982.

Section 2. The Council declares that an emergency exists in order that Micki Cross be fairly compensated without delay; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
