## ORDINANCE No. 153068

An Ordinance authorizing the transfer of \$150,000 from the Insurance and Claims Operating Fund to the Exposition-Recreation/Memorial Coliseum Fund, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The Insurance and Claims Operating Fund maintains reserves on behalf of those City funds that support activities covered under the City's general and fleet liability self-insurance program.
- 2. Such a reserve is currently held on behalf of the Exposition-Recreation/Memorial Coliscum Fund.
- 3. An analysis has been made of the claims history and degree of exposure within the operations of E-R/Memorial Coliseum to evaluate the adequacy of the reserve.
- 4. Based upon that analysis, the current reserve exceeds necessary levels and \$150,000 can be refunded to the E-R/Memorial Coliseum Fund.
- 5. The Commissioner of Public Safety recommends this refund be made at this time.

NOW, THEREFORE, The Council directs:

a. The amount of \$150,000 is transferred from the Insurance and Claims Operating Fund to the Exposition-Recreation/Memorial Coliseum Fund according to the following schedule:

Section 2. The Council declares that an emergency exists in that a refund, when appropriate, should be expedited as quickly as possible; therefore this Ordinance shall be in force and effect from and after its passage by the Council.
