

ORDINANCE No. 153080

An Ordinance authorizing the restoration of forfeited accrued vacation time to the vacation account of Police Officer John D. Howard, Bureau of Police, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Section 4.16.04 subsection (b) of the City Code limits the amount of accumulated vacation hours at the end of the first pay period in January to an employee's vacation accrual for the preceeding 24 month period.
2. Police Officer John D. Howard had two hundred (200) hours of vacation accrued in excess of 24 month earnings.
3. Because the above Officer was on temporary disability, he was unable to utilize the accumulated vacation hours.
4. That said excess hours of accumulated vacation time were therefore forfeited.
5. That it is the recommendation of the Chief of Police and the Commissioner-in-charge that the hours of forfeited vacation time be restored.

NOW, THEREFORE, the Council directs:


- a. Two hundred (200) hours of accumulated vacation is restored to the vacation account of Police Officer John D. Howard.

Section 2. The Council declares that an emergency exists because it is necessary that payroll records accurately reflect vacation account status; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
