

ORDINANCE No. 153082

An Ordinance amending Ordinance No. 152998 passed by the Council March 24, 1982, being an ordinance assessing upon certain property the cost of repairing and constructing sidewalks, curbs and driveways in front thereof for the one-month billing period ended December 31, 1981, by cancelling the assessment for Lot 7, Block 3, Laurelwood Park Addition, and reducing the total assessment by \$139.92, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 152998 passed by the Council March 24, 1982 assessed Lot 7, Block 3, Laurelwood Park Addition, \$139.92 for the repair and construction of sidewalks, curbs and driveways in front thereof for the one-month billing period ended December 31, 1981, and entered in City Lien Docket Book 125, Page 312.
2. This was paid as an invoice before entering the assessment procedure and the assessment should be cancelled.

NOW, THEREFORE, the Council directs:


- a. Ordinance No. 152998 is amended by cancelling the assessment against Lot 7, Block 3, Laurelwood Park Addition, for \$139.92, and reducing the total assessment of \$16,605.94 to \$16,466.02.

Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
