ORDINANCE No. 153083

An Ordinance amending Ordinance No. 152890 passed by the Council February 24, 1982, being and ordinance providing for the assessment of costs and administration expenses and other charges, for the demolition of a commercial structure at 13 North Fargo Street, located on South 23.1 feet of Lot 3, Lot 4, Block 4, Williams Avenue Addition, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 152890 assessed the South 23.1 feet of Lot 3, Lot 4, Block 4, Williams Avenue Addition \$3,124.06 for the demolition of a commercial structure at 13 North Fargo Street and the lien was entered in the City Lien Docket Book 125, Page 311.
- 2. The correct legal description for the subject property is South 23.1 feet of Lot 3 and Lot 4, Block 3, Williams Avenue Addition and the lien docket should be corrected.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 152890 is amended by correcting the legal description from South 23.1 feet of Lot 3, Lot 4, Block 4, Williams Avenue Addition to South 23.1 feet of Lot 3, Lot 4, Block 3, Williams Avenue Addition.
- Section 2. The Council declares an emergency exists because the lien should be correctly entered in the City docket in order to protect the City's interest as against possible future purchases; therefore this ordinance shall be in force and effect from and after its passage by the Council.
