ORDINANCE No. 153084

An Ordinance authorizing the Purchasing Agent to call for bids to purchase six combination pump-turbines for the Groundwater Development Program, Bureau of Water Works, authorizing a contract, authorizing the drawing and delivery of warrants and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Water Works requires the acquisition of six (6) combination pump-turbines for the Groundwater Development Program.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall advertise for bids using plans and specifications filed in his office on APR 9 1982 and, in the event that no satisfactory bid is received, shall readvertise on the same basic plans and specifications until a satisfactory bid is received.
- b. A contract is authorized with the most favorable bidder as designated by Council.
- c. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1981-82 and 1982-83 Budgets, Water Fund, Projects No. 3700 and 3800, BUC 18600374, Object Code 630 (Improvements), when demand is presented, approved by the proper authorities.
- Section 2. The Council declares that an emergency exists because a delay in proceeding with the purchase may result in additional expense and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
