

ORDINANCE No. 153084

An Ordinance authorizing the Purchasing Agent to call for bids to purchase six combination pump-turbines for the Groundwater Development Program, Bureau of Water Works, authorizing a contract, authorizing the drawing and delivery of warrants and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Water Works requires the acquisition of six (6) combination pump-turbines for the Groundwater Development Program.

NOW, THEREFORE, the Council directs:


- a. The Purchasing Agent shall advertise for bids using plans and specifications filed in his office on **APR 9 1982** and, in the event that no satisfactory bid is received, shall readvertise on the same basic plans and specifications until a satisfactory bid is received.
- b. A contract is authorized with the most favorable bidder as designated by Council.
- c. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1981-82 and 1982-83 Budgets, Water Fund, Projects No. 3700 and 3800, BUC 18600374, Object Code 630 (Improvements), when demand is presented, approved by the proper authorities.

Section 2. The Council declares that an emergency exists because a delay in proceeding with the purchase may result in additional expense and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
