ORDINANCE No. 153089

An Ordinance amending Subsection "b" of Ordinance No. 152427 to correct the funding source from which payment for a sewer easement was drawn in connection with the SE 91st Avenue, SE Velma Court and Private Property Sanitary Sewer Project, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 152427, passed by Council October 21, 1981, accepted a sewer easement for the SE 91st Avenue, SE Velma Court and Private Property Sanitary Sewer Project and authorized payment for the sewer easement in the amount of \$483.50.
- 2. Subsection "b" of Ordinance No. 152427 incorrectly authorized the warrant in payment for the sewer easement to be charged to the LID Construction Fund, BUC 74200231.
- 3. Payment for the easement should have been made from the General Fund (43300016), Appropriations, Contributions and Advances to Improvement Districts.

NOW, THEREFORE, the Council directs:

- a. That Subsection "b" of Ordinance No. 152427 be amended to read as follows:
 - "b. The Mayor and Auditor to draw and deliver a warrant in payment for the above described easement in favor of the following:

Grantor: Edward I. Strader and Beverly J. Strader

Amount: \$483.50

Address: 8863 SE 91st Avenue, Portland, Oregon 97266

said warrant to be charged to the General Fund (43300016), Appropriations, Contributions and Advances to Improvement Districts."

Section 2. The Council declares that an emergency exists because delay in enactment of this Ordinance would result in a delay in correcting the General Fund and the LID Construction Fund balances; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
