ORDINANCE No. 153098

An Ordinance withdrawing Tax Lots 12, 13, 4, 30, 31, 34, 19, 20, 110 and Tax Lot 36 North of Slough, Section 1, TlN, RIE, W.M., annexed to the City of Portland, from Rose City Water District.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Tax Lots 12, 13, 4, 30, 31, 34, 19, 20, 110 and Tax Lot 36 North of Slough, Section 1, TlN, RIE, W.M., has been annexed to the City by Portland Metropolitan Area Local Government Boundary Commission Final Order No. 1712, effective May 21, 1981, pursuant to ORS 222.180.
- 2. Under ORS 199.510, 222.520 and 222.524, the City may cause the annexed area to be withdrawn from a water district. Rose City Water District has no outstanding bonded indebtedness and, therefore, no assumption of such debt is involved.
- 3. The City Council fixed a date, time and place for hearing on the said withdrawal of said area from said district for March 24, 1982 at 9:30 a.m., in the Council Chamber of the City Hall, and notice thereof was duly given, all in accordance with provisions of ORS 222.524. Said district was duly informed of said proposed action to withdraw and has made no objection thereto.

NOW, THEREFORE, the Council directs:

- a. The City has no proportionate share of said property in the outstanding bonded indebtedness of said district to assume as the bonded indebtedness is found to be zero at the present time and no obligation is known to exist subject to such assumption.
- b. The property described in Exhibit 'A' is hereby withdrawn from said district:
