

## ORDINANCE No. 153110

An Ordinance authorizing the gift of a valueless chair to Juanita Wade, waiving City Code Section 5.36.010, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- (1) Juanita Wade is retiring after employment by the City in excess of 26 years.
- (2) She offered to purchase her chair at the City's original cost.
- (3) The chair has no present value.
- (4) In order to allow presentation of the chair as a gift, it is necessary to waive City Code Section 5.36.010.

NOW, THEREFORE, the Council directs:


- a. City Code Section 5.36.010 is waived so that the City can give Juanita Wade her chair.

Section 2. The Council declares that an emergency exists in that it is necessary to authorize this action as quickly as possible; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
