An Ordinance accepting a Bill of Sale from Sylvan Water District for water service lines and meters, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Areas in the Sylvan Water District have been annexed to the City of Portland.
2. Said District, pursuant to the resolution of its Board of Commissioners, has executed a Bill of Sale from District conveying title to the City of Portland of water service lines and meters within the Sylvan Water District.
3. Consideration for the transfer of the water service lines and meters to the City of Portland is the assumption by the City of the responsibility for maintenance of same.

NOW, THEREFORE, the Council directs:


- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a Bill of Sale from Sylvan Water District, attached to the Original only, marked Exhibit "A".

Section 2. The Council declares that an emergency exists in that transfer of title to the water service lines and meter should be made as soon as possible; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
