

ORDINANCE No. 153118

An Ordinance authorizing the Purchasing Agent to call for bids to construct and test pump production and test wells for the Bureau of Water Works, authorizing a contract, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Water Works requires the construction and test pumping of production wells and test wells for the Groundwater Development Program. These wells are to be constructed under the project title of "East Well Field Production Wells -- Phase IV".

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall advertise for bids using specifications filed in his office on **APR 16 1982**, and in the event that no satisfactory bid is received, shall readvertise on the same basic specifications until a satisfactory bid is received.
- b. A contract is authorized with the most favorable bidder as designated by the Council.
- c. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1981-82 Budget, Water Fund, Bureau of Water Works, RU 186, BUC No. 18600374, Object Code 630, when demand is presented, approved by the proper authorities.

Section 2. The Council declares that an emergency exists because a delay in proceeding with the purchase may result in additional expense, and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
