She frequently speaks out to our youth in forums at the grade school, high school and college levels, stressing the need for social change to eradicate racism and sexism. She constantly tries to influence young people-of all races--to expand their horizons. Her numerous awards include a citation from the Urban League for Devotion to the League's Concept of Equality; as well as being selected by Willamette Week in 1978 as one of the 10 most influential Blacks in Oregon; and a 1983 award as one of 10 outstanding Women of Oregon.

Why do you feel this individual or organization should receive the Russell A. Peyton Award? Judge Deiz has devoted her adult life to the cause of improving Human Relations through her commitment to racial and sexual equality and to the ideals by which she has lived. She

has been an inspiration to many, having risen from work as a legal secretary, to graduating from law school, to a career first as a lawyer and then as a Judge. She is a nationally-recognized expert in the field of Family Law and the overall court system. She also is a noted lecturer on the rights of minorities, race relations and juvenile law.
