**AMENDMENT No. 3 to  
CONTRACT No. 30007795  
FOR  
BEHAVIORAL HEALTH EMERGENCY COORDINATION  
NETWORK**

This Amendment No. 3 amends Contract No. 30007795 dated the 1st day of January, 2021, by and between Lones Management Consulting LLC (“Contractor”), an Oregon LLC, and the City of Portland, a municipal corporation of the State of Oregon (“City”) by and through their duly authorized representatives. This Amendment may refer to Contractor and City individually as a “Party” or collectively as the “Parties.”

This Amendment is authorized by City Code 5.68.035.B.2.

The Effective Date of this Amendment is July 1, 2022. The purpose of this Amendment is to add funds to the Contract’s not-to-exceed value.

The Contract was previously amended as follows:

Amendment 1, dated December 20, 2021, which increased the original not-to-exceed amount of the Contract from \$15,000 by \$750,000 to a new total not-to-exceed amount of \$765,000, and which extended the Term from December 31, 2021 to December 31, 2022.

Amendment 2, dated May 16, 2022, which increased the not-to-exceed amount of the Contract from 765,000 by \$400,000 to a new total not-to-exceed amount of \$1,165,000.

The Parties agree to Amend the Contract as follows:

1. The Contract not-to-exceed amount of \$1,165,000 is increased by \$335,000 to a new total not-to-exceed amount of **\$1,500,000**.

All other terms and conditions of the Contract remain unchanged by this Amendment and in full force and effect.
