

ORDINANCE NO. 32931 Ordinance to facilitate

An Ordinance Repealing Certain Ordinances, and declaring an emergency.

The City of Portland does ordain as follows:

SEC. 1. REPEAL OF ORDINANCES. The following ordinances

and parts of ordinances and all ordinances amendatory thereof are hereby repealed:

Ordinance No. 21165, entitled, "An ordinance prohibiting the discharge or firing of fireworks and other pyrotechnic display, and to limit their sale and storage." Passed April 27, 1910.

Ordinance No. 27003, entitled, "An ordinance prohibiting the erection of any gasometer, gas tank or gas pumping station within two hundred fifty feet of any church or residence in the City of Portland, and declaring an emergency." Passed May 14, 1910.

Ordinance No. 29083, entitled, "An ordinance making it the duty of the owner, person in possession and agent of the owner of any lot, tract or piece of land during certain months to cut and keep cut and removed therefrom and from the half of the adjoining street or streets abutting the property, weeds and certain other vegetation and during all months of the year to keep removed therefrom stagnant water, rubbish and other unsanitary substance and to keep the sidewalk in front of such property free from earth and other obstructions, declaring the failure so to do to be the creation of a public nuisance and providing for the removal thereof by the City Engineer and assessing the cost upon the property, repealing Ordinance No. 27305 and any provision of any other ordinance conflicting with this ordinance, and declaring an emergency." Passed June 11, 1914.

Ordinance No. 31467, entitled, "An ordinance regulating the exhibition of pictures, charts, casts or figures showing diseases of the human body, and declaring an emergency." Passed March 1, 1916.

Ordinance No. 4678, entitled, "An ordinance to prevent and suppress gaming and gambling houses and all places where any game in which chance predominates is played for anything of value; and to punish any person who engages in any such game, or keeps or frequents any such house or place." Passed September 16, 1885.

Ordinance No. 1912, entitled, "An ordinance to prevent and suppress gaming and gambling houses and all places where any game in which chance predominates is played for anything of value; and to punish any person who engages in any such game, or keeps or frequents any such house or place." Passed June 26, 1912.

Ordinance No. 23935, entitled, "An ordinance making it unlawful to exhibit or expose certain devices in rooms barred or barricaded in such manner as to render them difficult of access by officers of the law, prohibiting the visiting thereof by the public, providing a penalty therefor, and declaring an emergency." Ordinance No. 25314, entitled, "An ordinance to prevent and suppress betting on baseball games in the City of Portland." Passed May 22, 1912.

Ordinance No. 4710, entitled, "An ordinance to prevent and suppress bawdy-houses and places where fornication is enacted, and to punish keepers, inmates, and frequenters thereof." Passed November 4, 1885.

Ordinance No. 20070, entitled, "An ordinance to prohibit in the City of Portland, the carrying on of any marriage brokerage business, prohibiting the publication and circulation of advertisements for matrimonial purposes, and declaring an emergency." Passed September 22, 1909.

Ordinance No. 24936, entitled, "An ordinance providing for the suppression of the loan, gift, sale and distribution of any lewd, obscene or indecent book, magazine, pamphlet, newspaper, story paper, photograph, drawing, picture, engraving or postcard suggestive of lewdness, indecency or immorality, and providing for the punishment of the person or persons violating such ordinance." Passed March 13, 1912.

Ordinance No. 26156, entitled, "An ordinance requiring the owner or owners of property whereon buildings are situated which are used for certain purposes, to place and maintain thereon a plate or sign giving their names and addresses, and providing a penalty for violations thereof." Passed October 23, 1912.

Ordinance No. 24735, entitled, "An ordinance prohibiting the carrying of concealed weapons, repealing Section 12 of Ordinance No. 14049, and declaring an emergency." Passed January 24, 1912.

Ordinance No. 30034, entitled, "An ordinance making it unlawful to mischievously, wantonly or without having reasonable grounds for believing that a destructive fire exists to give, send or transmit an alarm of fire to the Bureau of Fire of the City of Portland, providing a penalty for violations hereof, and declaring an emergency." Passed January 15, 1915.

Ordinance No. 25477, entitled, "An ordinance prohibiting the employment of women in Pool Rooms, Bowling alleys, places where Boxball Games are carried on, Saloons or in Cigar stands located immediately adjacent to Saloons, and providing a penalty for the violation thereof." Passed June 26, 1912.

Ordinance No. 25019, entitled, "An ordinance prohibiting the employment of women in shooting galleries, and providing a penalty for violations thereof." Passed April 10, 1912.

Ordinance No. 31165, entitled, "An ordinance defining a coffee house, prohibiting the person owning or conducting a coffee house from employing any female person or persons therein, or permitting such person or persons to loiter or remain in or about such place, and providing a penalty for the violation thereof." Ordinance No. 24392, entitled, "An ordinance making a certain regulation of theatres that are resorted to chiefly by men." Passed November 22, 1911.

Ordinance No. 14027, entitled, "An ordinance prohibiting the sale of firearms or explosive cartridges to minors under the age of eighteen years." Passed June 1, 1904.

Ordinance No. 30659, entitled, "An ordinance regulating the participation of certain minor children in public entertainments." Passed July 7, 1915.

Ordinance No. 29728, entitled, "An ordinance regulating the sale of newspapers, periodicals and magazines on the streets within the City of Portland by minors, and providing a penalty for violations hereof." Passed October 28, 1914.

Ordinance No. 26826, entitled, "An ordinance prohibiting the sale of tobacco, cigars or cigarettes to minors under the age of twenty-one years, prohibiting the furnishing to, or the use of, tobacco, cigars or cigarettes by such minors in any public place, and repealing Section 69 of Ordinance No. 14049, entitled, 'An Ordinance concerning offenses and disorderly conduct' approved June 17, 1904." Passed March 26, 1913.

Ordinance No. 28401, entitled, "An ordinance amending Section 1 of Ordinance No. 26826 of the City of Portland, prohibiting the sale of tobacco, cigars or cigarettes to minors under the age of twenty-one years." Passed January 14, 1914.

Passed June 26, 1912. *a Vetoed Ord. & Veto sustained*

Ordinance No. 25684, entitled, "An ordinance fixing the minimum rate which may be charged by any person, firm or corporation, furnishing gas or electricity in the City of Portland, and providing a penalty for violations thereof." Passed August 14, 1912.

Ordinance No. 25685, entitled, "An ordinance requiring the operation of street cars during certain hours of the night." Passed August 14, 1912. *a Vetoed Ord. & Veto sustained*

Ordinance No. 31933, entitled, "An ordinance providing that all vehicles operating upon definite routes over the streets of the City of Portland and carrying passengers, for hire, shall not be operated in said City except under a franchise granted by the City of Portland." Passed July 19, 1916.

Ordinance No. 16886, entitled, "An ordinance to prevent trusts and combinations in restraint of trade within the City of Portland." Passed August 28, 1907.

Ordinance No. 25779, entitled, "An ordinance requiring all persons, firms and corporations receiving deposits of money from employes to pay interest on same, and providing a penalty for violation thereof." Passed August 28, 1912.

Ordinance No. 28894, entitled, "An ordinance prohibiting the opening of shops, stores and groceries on Sunday, and providing a penalty for violations." Passed April 29, 1914.

Ordinance No. 27088, entitled, "An ordinance prohibiting untrue, deceptive and misleading assertions, representations or statements of fact in advertisements within the City of Portland, and providing a penalty for the violation thereof." Passed May 14, 1913.

SEC. 2. EFFECT OF REPEALS. This ordinance shall not revive any ordinance which has been repealed by any of the ordinances mentioned herein, or cause the discontinuance of, or annul any proceeding pending under said ordinances, or impair any rights thereunder which may have accrued to the City of Portland.

SEC. 3. EMERGENCY. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That the great number of ordinances in effect at the present time causes confusion and uncertainty as to the law of the City; therefore an emergency is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
