Emergency Ordinance

*Pay settlement of Richard Blakeslee bodily injury lawsuit for the sum of \$45,000 involving the Portland Bureau of Environmental Services and Portland Bureau of Transportation

Passed

The City of Portland ordains:

Section 1. The Council finds:

- 1. Richard Blakeslee, through attorney Charley Gee, has filed a lawsuit against the City for injuries suffered in an encounter with a defective asphalt surrounding the maintenance hole cover involving the Portland Bureau of Environmental Services and the Portland Bureau of Transportation on April 26, 2018.
- 2. The lawsuit has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable.

 Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the lawsuit at this time.
- 3. Risk Management Services recommends the lawsuit be compromised for the total sum of \$45,000, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- A. The Mayor and Auditor are hereby authorized to draw and deliver a check in the amount of \$45,000 made payable to Charley Gee P.C. in trust for Richard Blakeslee.
- B. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (A) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this bodily injury lawsuit; therefore, this Ordinance shall be in full force and effect from and after its passage by the

Impact Statement

Purpose of Proposed Legislation and Background Information

This Ordinance settles a bodily injury lawsuit brought by Richard Blakeslee, resulting from a fall from his bicycle in southeast Portland.

Financial and Budgetary Impacts

This legislation will have no impact on City revenue.

Total cost to the City to settle the lawsuit is \$45,000. The source of funding is the City's Insurance and Claims Fund. All cost of the settlement is in the current fiscal year. This Ordinance does not amend the budget.

Community Impacts and Community Involvement

This Ordinance settles a lawsuit resulting from a bicycle incident after encountering a defective sewer manhole cover involving the Portland Bureau of Environmental Services and the Portland Building of Transportation. No public involvement or input was sought regarding this Ordinance. The City Attorney's Office and Risk Management have concluded that it is not appropriate to have public involvement in settlement negotiations regarding tort claims or lawsuits against the City.

No future public involvement is anticipated or necessary. Approval by City Council of this Ordinance will fully settle a tort claim against the City of Portland.
