# AMENDMENT No. 1 to IGA No. 30007938

### **FOR**

### **Emergency Rental Assistance Program – 2 (ERAP-2)**

This Amendment No. 1 amends IGA No. 30007938 dated 1st day of July, 2021, by and between Home Forward, Subrecipient, a Nonprofit Organization of the State of Oregon, and the City of Portland, a municipal corporation of the State of Oregon ("City"), by and through their duly authorized representatives. This Amendment may refer to Subrecipient and City individually as a "Party" or collectively as the "Parties."

This Amendment is authorized by City of Portland Ordinances No. 190356 and [To be determined].

The Effective Date of this Amendment is 10/1/2022. The purpose of this Amendment is to extend the term of the IGA in section B: Effective Date and Duration; and increase the not to exceed funding amounts and sources in sections D. Compensation, F. Reimbursement, Exhibit E and Exhibit G.

The Parties agree to Amend the IGA as follows:

1. **Section B. Effective Date and Duration**: Section B is hereby deleted in its entirety and replaced with the following:

The effective date of this Agreement is July 1, 2021 ("Effective Date"), and shall remain in effect until, and including, June 30, 2023 ("Expiration Date") unless terminated or extended as provided in this Agreement. Subrecipient may not spend grant funds after the agreement terminates or expires.

2. **Section D: Compensation:** Section D is hereby deleted in its entirety and replaced with the following:

The total Agreement amount is \$19,722,495.32. Subrecipient match is not required under this subaward. This amendment allocates additional funding in the amount of \$1,552,691.32, comprised of the following sources: \$161,107.32 in ERA2 funds; \$1,156,198 in ERA1 reallocated funds; and \$235,386 in CDBG-CV funds.

3. Exhibit E – Information Required by 2 CFR 200.332: Exhibit E is deleted in its entirety and replaced with the updated Exhibit E and appears as Attachment 1 to this amendment.

- 4. **Section F: Reimbursement:** Section 2, item 1, is hereby deleted in its entirety and replaced with the following:
  - "1. City will provide advances or reimbursements to the Subrecipient for eligible costs in carrying out the Project as identified in this Contract not to exceed \$19,722,495.32. All advance requests and/or invoice payments are conditional upon presentation of properly documented requests. Advances and reimbursements will be made upon approval by the City Contract Manager using documents as specified in **Exhibit G** (Request for Reimbursement) (RFR) or as amended and approved by the City Contract Manager. RFRs shall be submitted on or before 30 days following the end of each invoicing period, no less than on a monthly basis. Final RFR shall be submitted no later than 30 days following the end of the grant. Reimbursements for expenses will be withheld if required reporting obligations established by the Treasury Office of Inspector General are not submitted by the dates as listed in **Exhibit B** ("Treasury and City Reporting Requirements".)
- 5. **Exhibit G: Request for Reimbursement (RFR).** In Exhibit G, is hereby deleted in its entirety and replaced with the following as appears in Attachment 2.
  - "Payment shall be made by City of Portland on an immediate pay basis upon approval of Subrecipient RFR."
- 6. Adherence to the requirements for CDBG-CV funds. CDBG-CV funding will be used to provide rental assistance support for households experiencing financial loss and hardship due to the COVID-19 pandemic. All other terms and conditions of the IGA remain unchanged by this Amendment and in full force and effect.

This Amendment may be signed in two (2) or more counterparts, each of which shall be deemed an original, and which, when taken together, shall constitute one and the same instrument. The Parties agree that they may execute this Amendment by electronic means, including the use of electronic signatures.

# COVID-19 Rent Assistance Program: City October 2022 Funds

# **Program Guidelines**

### Purpose:

The COVID-19 Emergency Rent Assistance Program (ERAP) provides rent assistance to prevent households from experiencing evictions and homelessness due to the financial and health impacts of COVID-19. The priority is to serve communities experiencing the greatest adverse impacts from COVID-19, including Black, Indigenous, and other People of Color (BIPOC) and households with very-low incomes. The program includes funding from the Emergency Rent Assistance Program, allocation 2 funding, or "ERAP-2," allocation 1 "ERAP-1", and Community Development Block Grant-CARES Act ("CDBG-CV".)

Funds can serve households who are in rental housing or unhoused and can pay for the following eligible expenses: current or future rent payments (future payments limited to 3 months), rent arrears, security deposits and fees. Funds are <u>not eligible</u> to pay for mortgage payments, utilities or direct cash assistance. **CDBG-CV funds are eligible to pay a maximum of six months of assistance only**.

Funds should prioritize eviction prevention with a focus on payment of rental arrears allowable back to April 2020. Households who have received eviction notices for nonpayment of rent will be prioritized. Current and future rents can be paid in adherence to the program guidelines.

The deadline for funds to be submitted to Home Forward is December 9, 2022.

Adjustments might be needed based on changes federal guidance for the funds.

### **Eligible Households:**

To be eligible for the program, households must meet all three of the requirements below. There is no citizenship requirement for these funds.

- 1. Resident of City of Portland or Multnomah County
- 2. Experienced **both** of the following impacts due to COVID-19:
  - i. One or more individuals within the household has qualified for unemployment benefits; <u>or</u>, experienced a reduction in household income, incurred significant costs, or experienced other financial hardship due, directly or indirectly, to the coronavirus pandemic
  - ii. One or more individuals within the household can demonstrate a risk of experiencing homelessness; **or**, housing instability
- 3. Household income at or below 80% of Area Median Income (AMI)
  - Income is based on snapshot of current income at time of application the current gross income of all household members, or the household's total income for calendar year 2022.

### **Eligible Expenses:**

- Rent arrears and late fees
- Current and future rent payments. (Future rent payments limited to 3 months)
- Security, application fees and late fees
   Not eligible: utilities, mortgage payments, direct client assistance

### **Assistance Limits:**

An eligible household may receive up to 9 months of rent assistance. Prospective rent payments may not exceed 3 months of rent assistance, which is counted toward the total limit of 9 months of rent assistance.

Future rent assistance can be provided up to March 31, 2023.

<u>For households previously assisted with ERAP-1 or ERAP-2</u>: Households are limited to receive a maximum of 18 months total assistance from ERAP-1 and ERAP-2 funds.

<u>For households previously assisted with CDBG-CV</u>: Households are limited to receive a maximum of 6 months total assistance with CDBG-CV.

<u>Preference</u>: A preference is in place for households at or below 50% AMI, or households with one or more members who have been unemployed for at least 90 days before the date of application. A household who meets one of the preferences is eligible to receive up to 12 months of rent assistance.

### Intake Steps with Eligible Households:

- 1. Conduct a Pre-Screening to have household provide verbal confirmation that they meet all three eligibility requirements of the program:
  - ✓ Resident of Multnomah County (housed or unhoused)
  - ✓ Household income at or below 80% Area Median Income (AMI)
  - ✓ Experienced <u>BOTH</u> of the following impacts due to COVID-19:
    - Qualified for unemployment benefits OR experienced a reduction in household income, incurred significant costs or experienced other financial hardship due, directly or indirectly, to the coronavirus pandemic, AND
    - Demonstrate a risk of experiencing homelessness OR housing instability
- If the applicant provides verbal confirmation in meeting all three requirements, provide applicant with written proof of that a completed application has been submitted. This can be an email, text or letter. Sample language is provided in the Exhibit D: SB 278 Sample Letter Confirming Application to RA. Verbal confirmation alone is not sufficient.
- 3. Complete all forms of the Application Packet:
  - (1) Intake Form:
    - (i.) Includes verification of income eligibility, with instructions provided on **Exhibit B: Steps to Verify Income Eligibility**.
  - (2) Determine Rent Assistance Information:
    - (A) First Attempt: Assign Payment to Landlord: Complete the Agreement to Assign Rental Assistance and Landlord Information Forms and collect:
    - (i.) W-9 for Landlord (can be returned directly to Home Forward)
    - (ii.) A Property Management Agreement (PMA) may be requested if Home Forward needs to set up a new account.
    - (B) Second Attempt: Assign Payment to Renter:
      Must complete the Landlord Engagement Attempt Form and provide documentation verifying a rental agreement, and rent arrears or rent due, as outlined in section 5 of the ERAP-2 Intake Form.
  - (3) Multnomah County Release of Information
- 4. Collect the required tenant documents to submit together with the application packet. **Exhibit C: ERAP-2 Tenant Checklist of Documents** lists the required documents.
- Send application and required documents to Home Forward. Submissions must use the English application forms to ensure accuracy of payment processing and entry of participant data into fiscal and reporting systems.
- 6. Submit complete application to Home Forward by:
  - (1) Upload to secure City Share File site. Instructions included in Exhibit B.
  - (2) Fax: 503-802-8498
  - (3) Mail: Home Forward (Attn: CVRRP), 135 SW Ash St., Portland, OR, 97205
  - (4) Drop off: Home Forward's administrative offices are closed to the public, but there is a drop box with access from the exterior at 135 SW Ash Street, Portland, OR 97205.
