

AN ORDINANCE vacating certain parts of Oregon street between East Thirty-first street and East Thirty-third street in the City of Portland.

WHEREAS due notice was given, as required by the Charter of the City of Portland, that a petition would be presented to the Council praying for the vacation of certain parts of Oregon street, hereafter particularly described, which parts of said Oregon street are between East Thirty-first street and East Thirty-third street; and

WHEREAS, said petition was duly presented to the Council on the date named in said notice, to-wit: On Wednesday, July 28th, 1911, which petition duly set forth a description of the portion of said street so to be vacated together with a plat thereof and to which petition there was appended and as a part thereof and as a basis for such petition the consent of the owners in fee simple of two-thirds of the real estate fronting on both sides of said street or parts thereof sought to be vacated and along the entire length of such portions so to be vacated and two hundred feet in addition in each direction from the termini thereof, which consent was duly acknowledged in accordance with Section 362 of the charter of the City of Portland; and

WHEREAS, the Council upon the presentation of said petition and the filing off the proof of publication of said notice fixed the meeting of said council to be held on Wednesday the 26th day of July, 1911, as the time for hearing said petition and objections thereto; and

WHEREAS, said petition has been considered by the Council and no objections have been made or filed thereto; and

WHEREAS, THE Council has ascertained and determined and does hereby cause it to be made a matter of record that all of the acts and things required to be done in the matter of

such vacation have been done and that the consent of the owners
of the requisite number of front feet has been duly obtained
and that the public interests would not be prejudiced by the
vacation of said portions of said Oregon street; NOW THEREFORE:

THE CITY OF PORTLAND DOES ORDAIN AS FOLLOWS:-

Section 1. That the prayer of the petition herein-
before referred to be granted and that all of the following de-
scribed parts of Oregon street in the City of Portland be and
the same are hereby vacated, to-wit:

Commencing at the northwest corner of Lot 1, Block 18,
Laurelhurst; and running thence east along the north line of
Lots 1, 2, 3 and 4, Block 18, Laurelhurst; thence north, along
the west line of Lot 5, Block 18, Laurelhurst, 16.11 feet to the
northwest corner of said lot 5; thence east along the north line
of Block 18, Laurelhurst, to the northeast corner of Lot 10, Block
18, Laurelhurst; thence northerly on a continuation of the east
line of Block 18, Laurelhurst, 6.45 feet to a point 60.63 feet south
of the present north line of Oregon street; thence westerly in a
direct line to a point on the east line of East Thirty-first street,
97.14 feet south of the southwest corner of Lot 1, Block 1, Good-
sell's Addition to Portland; thence south 12.86 feet to the place
of beginning.

Commencing at a point in the east line of East Thirty-
first street 26.51 feet south of the southwest corner of Lot 1,
Block 1, Goodsell's Addition to Portland; and running thence east
along the north line of Oregon street to the west line of East
Thirty-third street; thence south 0.63 feet; thence westerly, in
a direct line, to a point on the east line of East Thirty-first
street 10.63 feet south of the place of beginning; thence north
10.63 feet to the place of beginning.
