## Ordinance No. 79182

An Ordinance designating and assigning a portion of Madrona Park for street purposes in connection with the Swan Island Access Road Project.

The City of Portland does ordain as follows:

Section 1. The Council finds that the tract of land herein described constitutes a portion of Fadrona Park which is owned by the City of Portland by fee simple title without restriction; that the strip of land herein described off the southeasterly portion of said park is required for use in widening N. Going Street and such use will contribute to the public convenience in the use of said park by providing better street access; now, therefore, the following parcel of property is hereby designated and assigned to the use aforesaid. Said parcel of property to be used for the purposes herein mentioned is particularly described as follows:

A portion of Madrons Park, in the northwest one-quarter of Section 21, T.IN., R.IE. of Willamette Meridian, described as follows: Beginning on the west line of vacated N. Delaware Avenue 185.0 feet south of the westerly projection of the south line of N. Elandena Street, when measured along said N. Delaware Avenue; thence northwesterly 106.0 feet, more or less, to a point on the easterly line of N. Greeley Avanue, as now laid out and established 180.0 feet south of the south line of N. Blandens Street, projected west, hen measured along a line parallel with the west line of vacated N. Delaware Avenue; thence southeasterly along the said easterly line of N. Greeley Avenue 155.0 feet, more or less, to an intersection with the west line of vacated N. Delawere Avenue; thence north elong said west line 65.0 feet, more or less, to the place of beginning; containing 2350 square feet, approximately, for the widening of N. Going Street for Swan Island Access Road.
