when we'd bike downtown, you would just see one person, or two sleeping in the cubby outside a business...

now without hardly any mental health surfaces, except portland st response, unity hosp, cascade behavior hlth, and a few others besides or. state hosp, everything will be a bandaid...

folks can thank gov ronald reagan in calif for that one back in the day, when he cut mental health, and let folks who needed help out on the streets...

until that funding is provided from fed, state, regional, and local, all bandaids approaches are futile....

it's a revolving door of mental health and hard core drug addiction, low police staffing, as we all know....

if the state legislature doesn't provide bi partisan funding with additional \$ from all regions nothing will work...

we bike downtown a lot to give our local businesses that struggled to stay open during covid, like hubers, dan/louis oyster bar, and food carts...

we love portland and want to see it be vibrant....

when we see maga types taking over the streets, it is frightening, in addition to the shootings

in our immediate neighborhood....

we all have to take a stand and take our streets back, building community..

we pick up trash, volunteer at local solve cleanups, and are engaged with our local n.a...

again when investors buy up so much housing stock, it pushes us out..

what kind of communitiy is that?

again, demolitions carve a community up, and rewards investors instead of people...

we support putting folks temporarily in some shelters that can be built today, like ww2 quonset huts with services, showers etc

it has to be brief to keep them safe from winter...

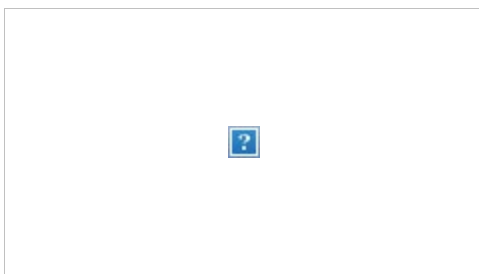
