The attached letter is believed to have been intended for ROBERT HORTON BRYANT, who is a black male and whose last known address was 1054 Myrtle Street, Plainfield, New Jersey, (201) 753-7981. BRYANT currently operates a business known as "Earth Family Project, Incorporated" and possibly an FM cable TV station with call letters WEFP. BRYANT is also suspected of being a former Black Panther Party member or sympathizer.

February 17, 1980

Greetings Bob,

They say the lights are going to be explosive, and indeed it looks like they are going to be. Here, a lot is happening (potentially) and what it amounts to is that our collective must ~~for~~ leave the area. This has got to happen quietly, and without the man knowing about it until after we have left. Because of this we all have got to take on new identities in the new areas. For when we leave there is going to be a lot of searching. There are a lot of things various departments would like to connect to destroy us - free us up. For one thing, one person is on \$50,000 appeal bond - facing a 15 year sentence! At this point we feel that it would not be a good idea to all move to the same place at once. We are ten in total that are leaving. Plus five children. Four of us should hook up with you for sure. As to how we would mold into the scene there, that is what we need to discuss. Aside from these four there are other people that could also go there (N.Y.) because they have skills that would be beneficial to you. One person has a radio license which could help you with the radio station. The reason we don't want to go to one place right now is that such an influx would ~~cause~~ notice. Unless people can just slide into things, moves would not be good. When we go we will fly, we will have new names, look different. ~~and~~ We can discuss when people can fly in either when we reach you, or if you can begin discussing it now through the mail. That would be good. Of the four people going

to N.J. I was to be one of them. But this car, and maybe a problem. I can no longer be myself, now will I look just like you saw me. But, when I was last there I met different people, as myself and I wonder what kind of a problem this would present. So, you must tell me if it is better that I not move there, and instead prepare for another place to move. Or if you have another area that I can go to? ~~OK~~

So, what we need to know is can you take four people right now - that's about 3 to 6 weeks time span? Do you have room for any children? The children are ages 4, 3, two, 2 year olds, and a 14 month old. If possible, it would be good to keep the 4 & 3 year old together, and the 2 two year olds together. That's the way they've been getting up pretty much so - those are the way these "Goldens" has gone. Of course it would be good for the 14 month old to be with them too, but what's most important with him is that he be with other children. Do you have the facilities for more people, elsewhere? Some of the skills that we have are radio work; one person has been to burglar alarm school & worked repairing burglar alarms; ~~one person has done~~ ^{people} ~~has done~~ painting ~~and some are like to go on with the work~~ some beginning electronics; one person is a typewriter repairman; one person just finished studying EMT (Emergency Medical Technician) and received the necessary certificates; one person has years of experience in body work - acupuncture - jin shin do, and body massage; and we all have a lot of experience in Collective Living, experimenting with multiple values

healthy living. If possible we would like to live with people - some form of collective living - 4-8 people - I guess. But, this is what we want, we will all do whatever we need to do. That is a fact!

We have put in storage equipment to start up a printing business, and later lay down the line we would like to get that together out there. Maybe fit it in to one that has started or start it ourselves. But, we'd create too much notice, we think, if you we did that right away. Now we need your opinion as we'll so your assistance.

Remember in regards to the people who have certificates or licenses that's all under their old name. The ones they can't use any more. But the skills are still there.

So, that's about it for starts. There's a lot we need to figure out real soon. I'll speak to you on Friday evening, about 8 P.M. EST. Should you need to reach me anything by mail address it to

WELLS SPRING COMMUNION (Tribal thorn-Red G. Family)

On October 14, 1979, seven inmates escaped from the King County Jail in Seattle, Washington. A shootout between law enforcement and the escapees and their two accomplices left one inmate dead and a Seattle police officer seriously wounded. The remaining escapees and their accomplices were subsequently apprehended.

On December 15, two inmates escaped from the Deuel Vocational Institute (DVI) in Tracy, California. To date, both remain at large, although evidence discovered by the Special Services Unit of the California Department of Corrections indicates that one of the escapees was gravely wounded when fired upon by a correctional officer during the escape.

Both of the above escapes were planned and carried out with the aid of the Wells Springs Communion, a California based group of revolutionaries operating a restaurant and apartment house in San Francisco and a remote ranch in Honeydew, California. Its members are well armed and use urban guerrilla techniques to carry out bank robberies, burglaries and thefts, including those of explosives. Weapons and explosives training has reportedly taken place in remote California locations. The group buys many of its weapons at gun shows, including those held in Sacramento and Vallejo. Weapons known to have been in its possession are M-16's, .30-06 rifles, shotguns, M-1 carbines, .45 caliber semi-automatic pistols and .357 Magnum revolvers. This equipment came off sale during several months. The past has included pipe bombs, dynamite, gas masks, infrared sensors, field instruments, and other equipment. The group has been active in the past in the area of the escape.



The escape was planned and carried out with the aid of the Wells Springs Communion, a California based group of revolutionaries operating a restaurant and apartment house in San Francisco and a remote ranch in Honeydew, California. Weapons and explosives training has reportedly taken place in remote California locations. The group buys many of its weapons at gun shows, including those held in Sacramento and Vallejo. Weapons known to have been in its possession are M-16's, .30-06 rifles, shotguns, M-1 carbines, .45 caliber semi-automatic pistols and .357 Magnum revolvers. This equipment came off sale during several months. The past has included pipe bombs, dynamite, gas masks, infrared sensors, field instruments, and other equipment. The group has been active in the past in the area of the escape.

The organization is multi-racial, and members are male and female, most of them young. Backgrounds range from those with no criminal history to convicts and ex-cons, etc. The group's philosophy, while basically Marxist, also includes feminism and is additionally heavily influenced by the libertarian sexual politics philosophy of Wilhelm Reich, an Austrian psychoanalyst who lived from 1897-1957 and was a follower of Carl Jung. In keeping with these philosophies, the females of the group play a sexually subservient role, often sleeping themselves with all males. The group is well disciplined, and the use of alcohol and drugs is prohibited. There are regular criticism-self-criticism sessions, and disciplinary actions against individuals often include abstinence from sexual intercourse with two or more persons occupying privileged and trust positions within the group.

While much of the information concerning the Wells Springs Communion remains circumstantial at this time, the involvement of felons and ex-felons and the revolutionary overtones of the group suggest that we may be witnessing the development of a revolutionary organization.

Wells Springs Communion recruitment efforts are on-going in jails, prisons, and in the community, and criminal activities of the group, once confined to California, have spread to neighboring states. There are indications that the group may plan to establish cells in Canada and Europe.

Attached find information describing the organizational structure and philosophy of the Tribal Thumb Community, now operating as the Wells Spring Commune. Also accompanying this material are investigative reports that should assist you in understanding the criminal activities associated with this group.

It is our belief that these people have ties on the East Coast, primarily the New York metro area. One letter seized during a search of their safehouse indicated that they were interested in making a move to the New Jersey area because of too much pressure from local authorities.

The Wells Spring, we believe, also has ties in Canada, particularly the British Columbia area. We also know that radio gear and Wells Spring code books were seized from the apartment of Marylin Bucks.

This group has been responsible for numerous prison and jail escapes in California and Washington. They have been found to use climbing gear and automatic weapons to affect these escapes.

It is well known in West Coast prison circles that Wells Spring will assist inmates in escape plans. California authorities have information indicating that Theresa Maria Ball is the main contact in regards to these escapes. She operates out of numerous mail drops in the San Jose, California area.

In the months following the escape of Artie Ray Baker, from the King County Washington jail and the subsequent arrest of William Dunne and Larry Jones, the Wells Springs operation suffered from internal fighting. The leadership changed hands and the key members either went underground or were arrested. It is believed that the group is trying to reorganize and is currently using females to contact other radical groups to join this organization.

Females, at this time, seem to be the main driving force and are controlling key administrative positions.

We also believe that the Wells Spring is becoming associated with the George Jackson Brigade (GJB). The GJB was responsible for numerous bombings and bank robberies in Washington and Oregon and California. Escaped Federal Prisoner John Sherman, who has ties in the Northwest and believed to be born in New Jersey, was the leader of the GJB. Key Wells Spring members Larry Jones and William Dunne, who are currently in custody at Walla Walla State Penitentiary, Walla Walla Washington, have aligned themselves with the GJB. At this time Sherman is a fugitive (EFP) and on the FBI's 10 most wanted. It was reported that he may have gone to Ottawa, Canada. Other sources indicated that he may be living in the New England States, working as a machinist. At this time we don't have any workable leads as to his whereabouts but it is not inconceivable that he may be in your area. One member of the GJB, Rita Brown, was a cellmate of Chesimards in Alderson and we believe provided her with contacts in our area.

It is our feeling that the Wells Spring group and the remnants of the GJB may now be aligned with the activists in your area. We would appreciate anything that you develop concerning Wells Spring, particularly the codes books if such exist.

On October 20, 1981, the Brinks armored car robbery occurred in Nyack, New York.

Subsequently, on October 21, 1981, a search warrant was executed at 223 Prospect Avenue, East Orange, New Jersey. Among items seized were a quantity of white index cards, each containing the name and credit card number of persons residing in the general area of Greenwich Village. These persons were interviewed and their available credit card monthly billing statements were reviewed. From this, it was determined that the one common business establishment in which all these persons used their respective credit cards was Kaminsteins Hardware Store, 29 Third Avenue, Manhattan.

Interviews conducted at Kaminsteins established that one LINDA WILLIAMS, a female, white, red hair, had been employed at the store from August, 1980, to October 17, 1981, three days ^{before} after the armored car robbery. In her capacity as a cashier, she did in fact have access to credit card receipts. In fact, the owner of Kaminsteins recalled that as a matter of course when WILLIAMS did hand in her store copies of credit card purchases, the carbon paper was missing. During her tenure at the store, WILLIAMS would often talk about California and Oregon.

It should be noted that also seized in the search conducted at 223 Prospect Avenue was a color polaroid picture of a female, white, apparently wearing a dark wig. This photo was shown at Kaminsteins and was identified as LINDA WILLIAMS. This photograph was also identified by Parole Officer CARL FRARACCI, whose name was found in the same location in East Orange, New Jersey. He identified her as one LINDA WILLIAMS who attended the Bond Street Dojo, where he was a martial arts student. In fact, she had on one occasion, visited his house.

On Saturday, December 19, 1981, said LINDA WILLIAMS was arrested at the Action Answering Service, 134 West 32nd Street. A surveillance had been established at this location after information was received that requests for duplicate birth certificates had been made via mail to the Registrar of Deeds, Fayetteville, North Carolina, and Onslow County Registrar of Deeds, Jacksonville, North Carolina, with a return address of this mail service. The requests were for duplicate documents of a male black and a female white. WILLIAMS was arrested when she appeared to pick up mail. She was subsequently identified as one

BETTY ABRAMSON, Date of Birth August 5, 1953, wanted for homicide in California. Said homicide occurred at a commune in Eureka, California, on June 2, 1980. Of particular interest is the fact that radios recovered during a search of a safe house at 2819 Barker Avenue, Bronx, New York, had call signs on them which had been assigned to the same commune. Also of note is the fact that a former member of this commune, one RICHARD BROWN, is a past boyfriend of fugitive, MARILYN BUCK. It should also be noted that a female who has been living with ABRAMSON in New York using the name of LONA COLE~~X~~ may in fact be a second subject wanted for the same homicide in California. She has not been apprehended at this time.

* Lona Cole has been positively identified as Wendy Sue Heaton, wanted for the same homicide as Abramson. A black male living with these two females has been identified as **Ricky Marcus Blanchard**, a former member of the same commune. He is wanted for escape from jail in San Francisco in August 1980. This is the Well Spring Commune of which we spoke. At present we believe strongly that Heaton & Blanchard fled to the New Orleans area (Blanchard's place of birth) in December 81, after we had grabbed ~~Heaton~~ Abramson.

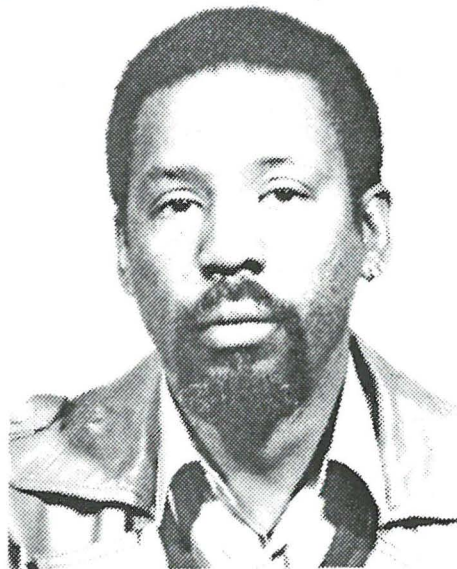
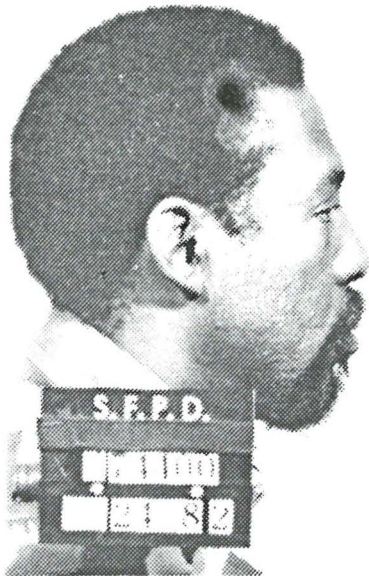

VEHICLE: 1968 Ford Mustang, license XZM 446. Has also been seen driving 1969/71 Cadillac, blue color, 2 door.

WEAPON: 9 MM Automatic used.

M.O.: On July 24, 1982 the above named suspect shot and killed two persons at 1793A McAllister Street, San Francisco, at the same time a third victim was also shot but this victim survived and is under police protection. Ernest Major Kirkwood works as a plumber and deals cocaine on the side. Kirkwood has lived at 1428 Steiner #B, 238 Ramsell, all in San Francisco. Officers should be warned that Kirkwood has been seen as late as 8/5/82 and 8/6/82 in the Liquor Store located at Sutter and Fillmore. Citizens who know the suspect have stated that he is carrying a gun and has expressed a wish to kill at least two other persons. Kirkwood has stated to friends that he intends to try his case in the streets if stopped by the police because he has nothing to lose. Kirkwood is a member of the Wells Spring Group, United Prisoners Union, and is very knowledgeable in the use of weapons. Extreme caution should be used if Kirkwood is observed due to the fact that he is suspected of being involved in other killings.

WARRANT: Warrant #252461, charging 187 P.C. (2 counts), 664/187 P.C., Action #11108-F, bail \$1,000,000, signed by the Honorable Judge Wonder, Judge of the Municipal Court was issued on July 29, 1982. Warrant on file and in PIN.

Man charged in jail escape linked to violent subversives

SEATTLE (UPI) — Seattle law enforcement officials believe a man who was arrested Sunday after aiding in the escape of seven prisoners from the King County Jail Sunday night is linked with a violent revolutionary group based in California that is headed by one of the escapees.

The man, tentatively identified as Lawrence Bailey, also is known to have ties with Charles Manson's "Helter Skelter" gang and the group, known as the Wellspring Communion, also has connections with the Symbionese Liberation Army.

Capt. John Leach, head of Seattle Police Crimes Against Persons section, said Bailey, 30, lived on the Wellspring Communion ranch located in Northern California that is headed by convicted murderer Artie Ray Baker, 25.

Baker, who is believed to have masterminded the escape, plus four other escapees and two suspected accomplices were captured within hours of the jailbreak. One prisoner, Roger Dale Raynor, 29, was shot to death. Still at large is David Warringer, 26, a habitual criminal sentenced to life in prison. King County police said Tuesday night that Warringer may be in Idaho heading for Montana.

"Baker organized it," Assistant U.S. Attorney Ronald Sim told a federal court hearing Monday. "He told people about the escape before it happened and said it would be his people who would be waiting outside to help."

Federal officials learned of Baker's remarks from three sources, including jail inmates, Sim said.

Police are not certain of the identity of the second accomplice, though he identified himself as William Crest. Both Crest and Bailey were wounded in the shoot-outs that followed the escape of the seven prisoners onto downtown Seattle streets. A Seattle police officer also was wounded seriously by gunshots fired from the car in which Bailey was arrested.

California records show that Bailey was a member of the Charles Manson group before Manson directed a

murder spree across Southern California that left seven persons, including actress Sharon Tate, dead in 1969. In 1971, Bailey was convicted along with other Manson "family" members of an armed robbery attempt on a Los Angeles sporting goods store in an effort to steal 140 guns.

Leach said Bailey identified himself as Jeffrey Pierce when he was arrested Sunday night, but police quickly learned the identity was false.

"We sent fingerprints to the Federal Bureau of Investigation and they returned the identity to us, but we wanted to make sure and contacted California authorities to get a confirmation before releasing his identity," Leach said.

Meanwhile, confidential police reports filed at the federal courthouse in Seattle link the members of the Wellspring Communion to the Symbionese Liberation Army, which kidnapped newspaper heiress Patricia Hearst in 1974, as well as a number of other revolutionary groups.

Humboldt County, Calif., Deputy Sheriff Dennis Dinsmore claimed in the records that the Wellspring Communion, once known as the Tribal Thumb, was "an offshoot of the SLA."

"The people in the Tribal Thumb have backgrounds in the Students for a Democratic Society, Weathermen, Black Panthers, Black Liberation Army and other guerrilla families," Dinsmore wrote.

His account paints a picture of an organization at odds with other radical groups during a period in 1977.

Courthouse records also show the group bought a 130-acre ranch in a remote area of Humboldt County and that one of the buyers listed on the deed was Marie Ferreboeuf, Baker's wife.

The confidential report was filed with the courthouse by Sim to back up his motion to have bail revoked for Ms. Ferreboeuf, who is free on \$50,000 bail while awaiting sentencing.

Last Seattle escapee captured near border

SEATTLE (AP) — The last of seven men who escaped in a weekend jail-break was apprehended near the Canadian border, loaded with new camping gear and toting an Army manual on avoiding capture, police said Wednesday.

The convict, David Warriner, 26, of Seattle, escaped Sunday from King County Jail. He was captured about

midnight Tuesday by a game warden checking on a possible poacher.

When the escapees broke out of the downtown jail, one was killed by gunfire and the others — except Warriner — were quickly captured. One policeman, still hospitalized in serious condition, was wounded, along with one of the escapees.

Washington Fish and Game agent Bob Ford said he found Warriner flashing a light through bushes six miles east of Blaine near the Canadian border.

"I just told him (Warriner) to stand in front of my car and keep his hands on the hood. . . . At that time, we carried on a casual conversation," Ford recalled Wednesday.

Warriner, convicted on burglary, shoplifting and drug charges, was sentenced to life in prison as a habitual criminal. When apprehended, he carried a knife with an 8-to-10-inch blade but no firearm, said Gene Guyant, deputy chief patrol agent for the Border Patrol.

Guyant said Warriner was sighted by Ford on a road that parallels the border. Ford said the State Patrol told him there was a man, possibly a poacher, about 100 yards south of the border.

When Ford approached, the man tried to flee, but Ford stopped him.

"If he would have played it smart with the Fish and Game official (by saying he was just hiking), nothing would have happened," said Guyant.

Border Patrol agent Keith Miller responded to Ford's call for assistance and took the man into custody.

The camping and survival equipment Warriner carried was new, said Guyant. "All of the labels were still on."

Seattle Police Chief Patrick Fitzsimons said Warriner may have been driven the 50 miles to the border by friends, who also may have supplied the survival equipment.

Slaying nets life sentence

SEATTLE (AP) — Artie Ray Baker, 26, was sentenced to life in prison Wednesday for the May 24 slaying of U.S. Customs Officer Kenneth G. Ward.

U.S. District Judge Walter McGovern also sentenced Baker to 10 years in prison for an assault on a federal officer and to one year in prison for an escape Sunday night from King County Jail.

Baker was accused of masterminding Sunday night's jail breakout by seven inmates armed with a pistol.

One escapee was killed and the other six have been captured. A policeman was seriously wounded in an exchange of gunfire.

Baker also is an escapee from a California prison, where he was sentenced for murder.

Baker is a member of the Wellspring Communion in Northern California, a group that helped engineer Sunday night's escape attempt, said U.S. Attorney Ron Sim.

Baker was convicted of pulling out a handgun and fatally shooting Ward, 34, as Ward questioned him at the border station at Lynden, Wash.

Baker fired at another officer while fleeing the scene.

Brink's Inquiry Seizes Fugitive From California

Slaying Suspect Held — Accomplice Is Sought

Investigators pursuing the Brink's armored-car holdup on Oct. 20 are looking into whether a woman arrested Saturday in Manhattan on unrelated murder and mail-fraud charges played a role in the Rockland County robbery.

Kenneth P. Walton, deputy assistant director of the Federal Bureau of Investigation, said a picture of the woman, Betty Jean Abramson, had been found in an apartment in East Orange, N.J., rented by a fugitive member of the holdup gang.

And Mr. Walton said a radio transmitter found at a Bronx apartment used as a hideout by the group, had also been traced through the Federal Communications Commission to a militant California commune of which Miss Abramson had been a member.

Had Been Sought Since 1980

Miss Abramson, 28 years old, had been sought by the authorities since June 1980, when she was charged with murdering another woman who had attempted to leave the commune. Officials in northern California's Humboldt County have associated the commune — Wells Springs Communion — with the Symbionese Liberation Army, the followers of Charles Manson, the killer of the actress Sharon Tate, and a San Francisco radical organization known as Tribal Thumb.

Another member of the Wells Springs Communion, Wendy Sue Heaton, is still being sought by authorities as an accomplice in the murder of Rosanne Goustin, 27, who was shot in the head after retrieving her belongings from the commune's 130-acre ranch.

Miss Abramson was arrested at 3 P.M. Saturday at a Manhattan mail-drop office where she had arranged to pick up identification papers requested fraudulently from North Carolina, Mr. Walton said. He said that members of a special task force assigned to investigate the aborted \$1.6 million Brink's robbery had kept the office under surveillance for 10 days before she appeared, requesting mail under an alias, Sharon L. Jarrell.

Registrar Became Suspicious

Agents started watching the mail-drop office after the registrar of deeds in Jacksonville, N.C., noticed that someone using the Jarrell name had written for a copy of her birth certificate, although the real Sharon L. Jarrell had died on the day she was born in 1963.

The registrar notified the F.B.I. Mr. Walton said.

Miss Abramson was arrested on two warrants, one from California for illegal flight to avoid murder prosecution and the other on mail-fraud charges issued two weeks ago by a Federal judge in North Carolina.

Several former members of the radical Weather Underground and Black Liberation Army have already been arrested in the robbery and resulting shootout, in which two police officers and a Brink's guard were killed.

She Is Held in \$500,000 Bail

Miss Abramson — dressed in faded blue jeans, a checked flannel shirt and sneakers — was arraigned yesterday in Federal District Court in Manhattan. After she refused to speak with a representative of an agency that interviews defendants for information used in setting bail, Magistrate Joel Tyler ordered her held in \$500,000 bail. Her address was given as 69 Beacon Street in Port Reading, N.J., where a "J. Abramson" is listed in the telephone directory.

The apartment in East Orange in which Miss Abramson's picture had been found was rented by Marilyn Jean Buck, a fugitive member of the Black Liberation Army. A getaway car used in the holdup was traced to Miss Buck, who has been convicted in California of using false identification to buy weapons.

According to law-enforcement officials in California, the Wells Spring Communion's ranch in Honeydew, south of Eureka, had been suspected of being used as a guerrilla training ground. The ranch is no longer considered active.

At the time of Miss Goustin's murder, on June 2, 1980, she and another woman not identified by the authorities were trying to move from the ranch to another site nearby. They were ambushed at their new home by Miss Abramson and Miss Heaton, both armed with handguns, according to officials.

Miss Goustin's friend fled, found a neighbor and came running back with him, just in time to see Miss Goustin forced to her knees and shot in the head by Miss Abramson, according to officials. The assailants fled, and Miss Goustin was taken to a hospital a two-hour drive away, where she died a few days later.

Link fem to terror gang

A woman arrested here Saturday on a routine federal warrant is wanted for killing a woman in a California terrorist commune and has links to the radical gang that allegedly killed three men in the Brink's truck heist in Rockland County, authorities said yesterday.

Betty Jean Abramson, 28, was ordered held on \$500,000 bail in the Metropolitan Correctional Center—where accused terrorists Kathy Boudin and Judith Clark are being held on murder charges in the Oct. 20 Brink's heist.

Abramson was arrested in Manhattan on charges of trying to obtain a false birth certificate—reportedly a prelude to getting other phony identification papers—in North Carolina by giving the name of a baby girl who died 28 years ago.

After her arrest, members of a city-FBI anti-terrorist task force learned that Abramson was wanted on a murder warrant in California.

AUTHORITIES SAID that Abramson and Wendy Sue Heaton, 25, fled California in June 1980, after reportedly killing Rosanne Gustin, 27, who lived with them at the defunct Wells Spring Commune in Eureka, 200 miles north of San Francisco.

Authorities said the women tried to stop Gustin from leaving the commune—allegedly a training camp for radical terrorists. Police said that Heaton pinned Gustin to the ground and that Abramson allegedly shot Gustin in the head. Heaton still is at large.

Lee Laster, head of the New York FBI office, said that a photograph of Abramson was found in an East Orange, N.J., hideout used by the gang charged in the Brink's holdup.

That hideout was rented by fugitive Marilyn Jean Buck, a member of the Black Liberation Army and a suspect in the heist.

Laster said that a search of another radical hideout turned up radio equipment that originally was located at the Wells Spring Commune.
