## RESOLUTION NO. 12496 -2....

WHEREAS, the Council of the City of Portland has instituted proceedings for establishing as a city street that portion of County Road No. 97 commonly known as Richmond Street lying between the southerly line of Jersey Street and the center line of Columbia Boulevard and has given notice thereof in the manner prescribed by the city charter and has passed Resolution No. 12261 directing the City Engineer to make a survey and plat of the same and a written report thereof and has by Ordinance No. 39812 adopted the report of the City Engineer made pursuant to said resolution, and

laying out and establishing of said street will necesalisate the taking over of the said portion of said county road and that no private property will be appropriated by said proposed laying out and establishing of said street by taking over said portion of said county road and therefore no award of damages or assessment of benefits was needed, and

WHEREAS, the County Court of Multnoman County, State of Oregon has deemed it necessary and expedient and for the best interests of said county to surrender jurisdiction over said portion of said county road, and the Council has deemed, and does now deem, it necessary and expedient and for the best interests of the city to acquire jurisdiction over said portion of said road to the same extent as it has over other public streets and alleys in the City of Portland and said Court fixed a time for a hearing upon the proposal of surrendering and turning over to the City of Fortland for a city street said portion of said county road and published notice of such hearing and at such hearing cortain written objections were made against said proposed action and said Court upon hearing and considering said objections and said matter, made and entered its order and decree on September 28, 1921, wherein and whereby it disallowed. denied and overruled all objections against such action and determined that it is necessary, expedient and for the best interests of said county to surrender jurisdiction over said portion of said county road to said city and by said order offered to the City of Portland to surrender such jurisdiction and fixed the time within which acceptance thereof might be made at thirty days from and after the date of said order and further ordered and decreed that from and after such acceptance the juris-

diction of said county over said portion of said road and over its improvement, construction and repair should cause and determine and the full and absolute jurisdiction over the same for all purposes of repair. construction and improvement and the levying and colo lection of assessments therefor and all other purposes should rest in said city and said city should have the same control, power and jurisdiction over the same as by its charter and the laws of the State of Oregon are given or granted to it for any of the public streets and alleys in said city, now, therefore, be it

RESOLVED that the City or Fortiese does hereby accept the terms and provintods of said order and doss hereby accept said portion of said county road as and for a street to be known and designated as Richmond Street and does hereby accept and assume full and complate jurisdiction over the same for all purposes of repair construction and improvement and the levying and collection of assessments therefor and all other purposes, and said portion of said dounty road is hereby declared to be a city street of the City of Portland and the same is hereby opened and ostablished as a street.

BE IT FURTHER RESOLVED that the Auditor forthwith forward to the Board of County Commissioners of said County of Multionah a copy of these resolutions.
