Resolution No. 13506 - 2

WHEREAS, a conference was held at two o'clock P.M. August 7, 1925, between the City Council, representative of the Board of County Commissioners of Multnomah County, the Bridge Engineers of Multnomah County, and the City Engineer, relative to the approaches to the new Burnside Bridge, on both sides of the river; and.

WHERRAS, the plans submitted by the Board of County Commissioners to the City Council, and the alternate proposals submitted by the Commissioner of Public Works, in his report dated July 30, 1923, to the Council were considered in detail; and,

WHEREAS, it is important that the widths of the streets and the approaches to the tridge be definitely fixed immediately in order that the street extensions and widenings carried on under proceedings by the City Council, and the plans for the approaches and bridge being prepared by the County of Multnomah may be completed as at as early a date as possible; now therefore.

BE IT RESOLVED by the Council of the City of Portland that the City Engineer be and is hereby instructed to acquire under Street Extension and Widening Proceedings the necessary parcels of land to perfect the street widths, as follows:

On the west side of the river Burnside street is to be widened to 110 feet in width from the harbor line to Park street by acquiring 50 feet on the north side of the street, except that block between the harbor line and Front street where the land acquired should lie within the area of 55 feet on both sides of the center-line of the bridge; Second street is to be widered by acquiring 10 feet on the east side of the street between Ankeny and Burnside streets: Third street is to be widened on the west side by acquiring 13 feet from Ash street to Couch street, and on the east side of the street by acquiring 13 feet from Ash street to Couch street. southeast corner of Second and Burnside streets, and the northeast corner of Third and Burnside streets are to be out off on a diagonal with dimensions of 20 feet on each side: the northeast corner of Second and Burnside streets is to be out off with dimensions of 10 feet on each side; and the southeast corner of Third and Burnside streets is to be cut off by acquiring a triangle with 25 foot dimensions on each siãe.

East Burnside street is to be widened by acquiring 25 feet on each side of the street from a point 100 feet west of the west line of Third street to the west line of Union avenue, and by acquiring 15 feet on each side of Rast Burnside street from the east line of Union avenue to the west line of East Thirteenth street; the northwest and southwest corners of East Burnside street and Union avenue are to be widened by acquiring triangular parcels with 25 foot dimensions on each side.

And, BE IT FURTHER RESOLVED by the Council of the City of Portland that it is the understanding that the County of Multnomah will acquire easements from the east harbor line of the Willamette River to a point 100 feet west of the west line of East Third street for a width of 110 feet, and that the County of Multnomah will contribute such sum as is necessary, but not to exceed \$62,000.00, to provide for the additional cost of acquiring 25 feet on each side of East Burnside street, and acquiring the triangular portions on the west side of Union avenue between a point 100 feet west of the west line of Third street and Union avenue, over and above the cost of acquiring 15 feet on each side as is now included in the Proceedings for the Widening of East Burnside Street by the City of Portland; and

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to the Board of County Commissioners of Multnomah County for their official approval.
